# Kentucky makes changes as it steps into new era of college athletics

lege athletics began July 1. Athletic programs, such as the University of Kentucky and its studentathletes, can partake in revenue-sharing with a cap expected to be approximately \$20 million. The number could climb to more than \$30 million in the next 10 years.

The \$20.5 million figure is an estimate based on a percentage of average revenue generated by "Power Four conferences" within various categories, including media rights, ticket sales, licensing and corporate sponsorships.

When combined with athletic scholarships, this figure represents approximately 50% of the total revenue allocated to athletes, akin to revenuesharing models in professional sports.

The Kentucky athletic department is "experiencing strong momentum" as it prepares for a pay-for-play model that will forever change the landscape of college sports.

This success reflects a broad-based commitment to excellence in all sports, even as the landscape of college athletics undergoes significant change," the

university said in a press release. The revenue-sharing model will add \$20 to 30 million to the school's yearly athletic budget, and the school is taking measures to absorb the immediate and future costs.

With this new framework, we will continue to do what it takes to remain competitive," Kentucky athletics director Mitch Barnhart said. "We will remain focused on education and competition, putting championship rings on fingers and diplomas in hands. We plan to not only survive but thrive. We will rely on our strengths: our innovative legacy, our position in the Southeastern Conference and the unified support of the University of Kentucky and the best fanbase in America, the Big Blue Nation.

'These are the cornerstones of our path forward."

A College Sports Commission has been formed and will be put in place "to facilitate revenue sharing in college sports and ensure that name, image and likeness (NIL) deals made between student-athletes and third parties are fair and comply with the rules."

Among the changes, Kentucky will be phasing out faculty and staff discount

tickets. The move will result in the elimination of the season ticket discount by the 2027 season. The school will transition to single-game admission for women's basketball, baseball, vollevball, gymnastics and softball starting with the 2025-26 school year. Complimentary K Fun Olympic sports passes will be discontinued.

In other changes, free admission will be offered for men's and women's soccer and ticket prices for children will be standard in all sports, while ticket pricing will include all fees that will be paid "up front," which the school said will be "in line with new FTC regulations" and will eliminate hidden charges.

Along with the changes, the school said the athletic program is "committed to offering access to events for university employees and fans ... select discounts may still be offered throughout the year, and the department will continue to evaluate pricing to maintain a strong home advantage while supporting long-term success."

"As we move forward, the Big Blue Nation's continued support remains crucial," Barnhart said. "Together, we can embrace these changes to elevate Kentucky Athletics to new heights."

### Ohio multi-sport athlete commits to Cats for football, baseball

Ponatoski, a four-star Ohio and baseball in the SEC. high school quarterback, committed Sunday night to Kentucky.

It is a double win for the Wildcats since Ponatoski will be joining the baseball team, too.

The 247Sports Composite ranks him as the No. 21 quarterback in the 2026 class.

As a junior at Archbishop Moeller High School in Cincinnati, Ponatoski was named the Gatorade Player of the Year in Ohio in both football and basketball.

He was named Ohio Mr. Football after throwing for 4,217 yards, 57 touchdowns and just three interceptions while leading his team to the OHSAA Division I state championship.

In the spring, he hit .462 in 27 baseball games.

"He was playing the best basketball of his career before his season was cut short and I'm ecstatic that he has The 6-6 guard scored in double figures in 17 games and paced the team in scoring four times before missing the final eight games of the season and 12 of the final 13 overall. Robinson drained at least three 3s in nine games and finished the year having made 62 longrange shots, which ranked second on the squad. He played the best basketball of his career against SEC competition, where he averaged 14.4 points across 11 games while shooting 46.2% from the field and 45.7% from 3-point range. Robinson topped the 20-point plateau on four occasions, including scoring 27 points and sinking seven 3-pointers in a win at Mississippi State. He also topped the 20-point mark with 22 and five 3s against

from-behind win against career to spend the last three Gonzaga, Robinson logged 18 points and five assists.

Robinson was tabbed the Big 12 Sixth Man of the Year in 2023-24 and was an All-Big 12 honorable mention honoree at BYU. He was the first bench player in BYU history to lead the team in scoring, averaging 14.2 points per game.

It was the second-most points scored by a Kentucky player against the Cardinals and his 10 made shots from the field tied for the third most without a miss in program history.

For his efforts, he was named the Bluegrass Sports Commission MVP, the Southeastern Conference Player of the Week and a United States Basketball Writers Association National Player of the Week.

#### **JAXSON ROBINSON**

Robinson was knocked out over halfway through his only Kentucky season because of injury.

Robinson agreed to a free agent contract with the Cleveland Cavaliers, the organization announced Thursday.

Robinson was a finalist for the Julius Erving Award honoring the nation's best small forward in 2024-25. He started all 24 games in which he appeared and averaged 13 points, 3.5 rebounds and 1.7 assists per game while shooting 43.2% from the field and 37.6% from distance.

He set career highs in rebounds per game, assists per game, field-goal percentage and 3-point field-goal percentage.

Robinson is the fourth Wildcat to earn an NBA opportunity. He joins Koby Brea and Amari Williams, who were second-round picks, and Butler.

Carr will get an NBA opportunity after signing with the Portland Trail Blazers, it was announced Friday. Carr averaged 10.3 points, 4.7 rebounds and 1.7 assists per game for the Kentucky in 2024-

Carr is the fifth Wildcat from their Sweet 16 team to earn his way on to an NBA roster. He joins Brea and Williams, who were second-round picks, as well as Robinson and Butler, who also signed free agent contracts.

The 6-11 forward was a team leader for the Cats and earned SEC Community Service Team

Carr logged a team-high 19 points on 8-of-12 from the field in the come-from-behind win over Gonzaga. He also chipped in seven boards and three assists, while playing the final 9:55 of the game with four fouls.
