ORDINANCE NO. 2025-11		
AN ORDINANCE AMENDING THE PERSONNEL AND PAY CLASSIFICATION PLAN FOR THE FISCAL YEAR BEGINNING JULY 1, 2025 AND ENDING ON JUNE 30, 2026 (Ordinance No. 2025-02)		
WHEREAS, KRS 83A.070 (2) and City of Calvert City Ordinance §31.02 (B) and (C) require the City Council to adopt a personnel and pay classification plan fixing the compensation of City employees and non-elected City officers; and,		
WHEREAS, the Mayor of the City of Calvert City has requested that the City of Calvert City not hire an Assistant City Manager and instead hire a Zoning & Compliance Officer; and,		
WHEREAS, City Council of the City of Calvert City has determined it to be in the best interest of the City of Calvert City not to hire an Assistant City Manager but to hire a Zoning & Compliance Officer and to establish a compensation schedule for such position.		
NOW THEREFORE BE IT ORDAINED BY THE CITY OF CALVERT CITY, COMMONWEALTH OF KENTUCKY that the personnel and pay classification plan for the City of Calvert City for the fiscal year beginning July 1, 2025, and ending on June 30, 2026, is amended, as follows:
