Audit reports 2 infractions in 2024

Kentucky Auditor Allison Ball has released the audit of the financial statements of the LaRue County Fiscal Court for the fiscal year that ended June 30, 2024. The schedule of findings and responses identified two deficits relating to the LaRue County Detention Center.

First, it states the fiscal court and LaRue County Jailer Jody Perry did not follow bidding procedures required by the Model Procurement Code for the LaRue County Detention Center's food service program and commissary vendor.

Per Kentucky law, of which the provisions have been adopted by LaRue County, all contracts and/or purchases by government agencies must be awarded through competitive sealed bidding. These bids are required to be opened publicly, and record must be made of any bids that were received and how bids were awarded.

"The fiscal court disbursed \$184,615 for the detention center's food service program without approving a bid for the service until April 23, 2024," the report states. "The jailer advertised in the newspaper for bids on food service to be opened Feb. 28, 2023; however, no documentation was provided as to the outcome of the bid advertisement ... In addition, the jailer did not bid disbursements of \$210,375 for the detention center's commissary vendor'

Jailer Perry disagreed with the audit's accusation that the jail incorrectly bid the food service program, stating the Notice of Bid Acceptance of the Food Service bids were adequately advertised in the local newspaper.

"The proof of the bid notice in the paper was provided to the Auditor," he said. "Regardless of it not being found in the Fiscal Court minutes. I for profits from commishave no control of what sarv sales in the inmate is entered into the minutes by the clerk. The newspaper ads should suffice as proof the notice of bid acceptance was completed."

Acknowledging that the food service bids were advertised in the newspaper as submitted, the auditor reiterated that bids are required to be open publicly and documented. Perry stated no corrective action would be taken, as he retains the position that the process was completed correctly.

Regarding the bidding of the commissary vendor, Perry cited KRS 441.135 and stated jailers are not required to bid commissary "as it is not a service paid for from the jail budget ... it is income."

In response, the auditor explained that state law forbids officials from entering any contract with a value of more than \$40,000 without first advertising for bids. This necessity remains whether county funds are being expended or not;

therefore, because the jail bank account was utilized to purchase commissary inventor to resell to inmates, the auditor holds that a bid for the commissary vendor should have been advertised. Although he opposed this conclusion, Perry said he already planned to bid the canteen services when the current contract matures in 2027.

The second deficit found that the detention center's year-end commissary financial report and bank reconciliations were not accurate.

"The jailer maintains two separate bank accounts to account for funds received from inmates: the Inmate Account and the Commissary Account," the report states. "The yearend commissary reports detailed receipts and disbursements from the Inmate Account and omitted receipts and disbursements of the Commissary Account. In addition, the ending book balance on the report did not include the book balance for the Commissary Account and does not agree with the jail's receipt and disbursement ledgers and bank reconciliations.

Conceding that the inmate account and commissary account do not correspond with each other, Perry said the two accounts are not meant to match because they are not incorporated which each other and are utilized for different purposes. While acknowledging that the accounts are separate, the auditor reiterated that both accounts are still required to be presented accurately.

Regarding the allegation that the jail's bank reconciliations were not accurate, the auditor stated, "[The jailer's year-end bank reconciliations | included incorrect amounts for outstanding checks and deposits-in-transit in both jail bank accounts. Further, the jail routinely accounts bank account instead of in the commissary bank account ... Due to inaccurately reporting funds in the correct account, the inmate bank account has an unexplained overage in the account of \$17,860 payable to the

commissary account." Perry also disagreed with this finding, stating, "As provided documents show, at most the overage is \$152, which is funds in transit between account reconciliations." Although the auditor rejected this claim and repeated the unexplained balance found, Perry said no corrective action will be taken "as we disagree with the finding in its entirety."

Overall, the report determined that the financial statements of the LaRue County Fiscal Court for the fiscal year that ended June 30, 2024, presents fairly in accordance with the regulatory basis of accounting generally accepted in Kentucky. The audit report can be found at auditor. ky.gov.

A special condition attached to KIA's loan approval tendered on May 1 was a requirement that the city pass a resolution "demonstrating their intention to increase revenues as necessary to maintain the KIA's required 1.1 debt coverage ratio." A KIA review indicates the city must increase its revenue by approximately \$140,000 by fiscal year 2027 to meet the loan requirement.

Hodgenville Mayor Iim Phelps presented the required resolution to the

City Council on Monday, stating that the increased rates would be determined by KIA and put into effect no later than July 1, 2026. The resolution was passed unanimously with a motion by Rita Williams and a second by Tony Stewart; council members Ryan Jeffries and Lisa Reidner were absent from the meeting and vote.

Other items approved at the May meeting include:

• The opening of a Restaurant Tax Checking Account; the city expects to begin collecting restaurant tax funds on July 1 and will subsequently disburse the funds to the Hodgenville Tourism and Convention Commission.
