## Lost City Solar Project approved with conditions

250-megawatt solar energy project planned for Muhlenberg County has received conditional approval from the Kentucky State Board on Electric Generation and Transmission Sit-

Lost City Renewables, LLC was granted a certificate on July 28 to construct the facility, which will span approximately 1,413 acres and include around 400,000 ground-mounted lar panels. The project will be located 0.4 miles east of Penrod and 1.25 miles northeast of Dunmor in Muhlenberg County, Kentucky. Electricity generated from the facility will connect to the Tennessee Valley Authority substation at 2557 Lost City Road

in Lewisburg via a new 10.8-mile, 161-kilovolt transmission line.

The Siting Board's approval includes a number of specific mitigation measures to reduce potential impacts on nearby residents and properties. These include required setbacks of 150 feet between solar panels and homes, 450 feet for central inverters and storage systems, and additional distances from property lines, roadways, churches, and schools.

The board also mandated visual buffers such as existing vegetation or new evergreen plantings, limits on construction hours, and site security fencing prior to activation of any electrical work. Lost City Renewables must also implement

a complaint resolution program and provide regular reports on community concerns.

A decommissioning plan must be submitted at least one month before construction begins, and a bond covering decommissioning costs will be required and filed with the Muhlenberg County Fiscal Court.

Other requirements include:

• Submission of a finalized site layout and emergency response plan

• Site-specific training for local emergency responders

• Pollinator-friendly landscaping on at least two acres

• Repair or reimbursement for any road or

bridge damage The Siting Board determined the project meets the requirements of Kentucky law, provided that all conditions are met. The full list of conditions, along with case documents and hearing videos, can be found at psc.ky.gov under case number 2024-00406.

The Siting Board includes members of Public Service Commission, representatives from state environmental economic development agencies, and local officials from the project area.

## Lovan family urges nationwide ban of Sig Sauer P320 handgun

GREENVILLE — The Lovan family is calling on the U.S. military, federal agencies, and law enforcement across the country to stop using the Sig Sauer P320 pistol and its variants following the death of Airman Brayden Lovan. Lovan, 21, died on July 20 at F.E. Warren Air Force Base in Cheyenne, Wyoming. According to officials, the M18 pistol he was carrying, the military version of the P320, discharged unexpectedly while he was on duty with the 90th Security

Forces Squadron. In response, the U.S. Air Force paused use of the M18 across its Global Strike Command and ordered inspections of the weapon. A formal investigation into the incident is ongoing.

The Lovan family is represented by Philadelphia attorney Robert Zimmerman, who also represents more than 100 individuals claiming injury or death from unintended discharges involving the P320 model. The family is concerned that another uncommanded firing could occur and is considering a wrongful death lawsuit against Sig Sauer.

Sig Sauer has denied that the firearm can discharge without the trigger being pulled and stated it is cooperating with the military's investigation.

Other agencies have also taken action in response to safety concerns. U.S. Immigration and Customs Enforcement (ICE) banned the use of the P320 earlier this summer. The Houston Police Department recently prohibited officers from carrying the weapon after an officer was injured by an alleged accidental discharge. Some units under the Air Force's Air Combat Command have also restricted M18 use, and departments in cities such as Milwaukee and Dallas have begun transitioning away from the platform.
