AN ORDINANCE SETTING THE TAX RATE FOR THE CITY OF CENTRAL CITY FOR THE TAX YEAR 2025 AND FOR MOTOR **VEHICLES FOR ASSESSMENTS AS OF JANUARY 1, 2025** 

BE IT ORDAINED BY THE CITY OF CENTRAL CITY, KENTUCKY,

- 1. The City Tax Rate for the tax year 2025 and for motor vehicle assessments as of January 1, 2025, shall be as follows:
- (a) Real Estate: 26.4 cents (\$0.264) per \$100 of assessed value.
- (b) Personal Property: 40.18 cents (\$0.4018) per \$100 of assessed value. (c) Motor Vehicles: 20.5 cents (0.205) per \$100 of assessed value, pursuant to KRS 132.487 for assessments as of January 1, 2025.
