Bright appears in court, has review set for May 9

Jeri Jo Bright appeared in Marion Circuit Court on April 14 and had a review set for May 9 at 1:00 p.m. by Judge Kaelin Reed.  
Bright was arrested on March 30, 2023, when deputies with the Boyle County Sheriff's Office obtained a warrant to search her residence, 46 Todd Drive, which is located directly behind Marion County Middle School. Once inside, deputies, assisted by the Marion County Sheriff's Office, located approximately ½ pounds of methamphetamine, over \$17,000 in cash, quantities of crack/cocaine, heroin, pills, marijuana, scales, numerous guns, and other drug para-

phernalia. There was also a juvenile in the residence. According to the arrest citation, the drugs were in a bedroom locked with a padlock inside a black safe.  
She was indicted by a May 2024 Marion Grand Jury and is currently facing 13 charges: First-degree enhancement trafficking in a controlled substance, first offense (equal to or greater than 2 grams methamphetamine), first-degree enhancement trafficking in a controlled substance, second or greater offense (less than 4 grams of cocaine), enhancement trafficking in a controlled substance, first

offense (heroin), first-degree enhancement trafficking in a controlled substance, two count of first offense (great or equal to 10 dosage units drug unspecified), third-degree enhancement trafficking in a controlled substance, second or greater offense (greater or equal to 20 dosage units drug unspecified), enhancement trafficking in marijuana-less than 8 ounces-second or greater offense, second-degree enhancement trafficking in a controlled substance, first offense (less than 10 dosage units hallucinogen), second-degree enhancement possession of a controlled

substance (drug unspecified), first-degree wanton endangerment, third-degree unlawful transaction with a minor, possession of a defaced firearm, and illegal possession of a legend drug.  
• Justin C. Wheatley's pretrial conference is set for May 22 at 1:00 p.m. He is charged with intimidating a participant in a legal process, operating a motor vehicle with an expired operator's license, failure to produce an insurance card, and menacing.  
• Monique Shilling Parks has a pretrial conference set for May 22 at 1:00 p.m. Parks is charged with first-degree possession of a controlled substance, first offense (methamphetamine), second-degree possession of a

controlled substance-drug unspecified, drug paraphernalia-buy/possess, controlled substance prescription not in original container, first offense, failure of owner to maintain the required insurance/security, first offense, operating on a suspended/revoked operator's license, and failure to wear seat belts. The Commonwealth will file a response brief by May 22. Parks is also charged with convicted felon in possession of a handgun, and operating on a suspended/revoked operator's license. A pretrial conference of May 22 at 1:00 p.m. has been set for those charges, and the Commonwealth will file a response brief by May 22.

of Education. Comer said the thought behind this is not just the monetary savings but putting control of the schools back into the hands of state and local authorities. He said, if passed, this would also allow teachers to focus more on teaching and less on hours of endless paperwork required by the federal government. He said the local schools and state level departments of education would still receive all the funding they have previously gotten. He also explained

the reasons behind the increased/new tariffs that have been proposed.  
Also at Thursday's court meeting, magistrates received an update from Chris Carter, Airport Manager at the Lebanon-Springfield Airport. Carter talked about the need to extend the runway and hopes for building additional hangars at the airport.  
The court opened sealed bids for several items:  
There were no bids for the animal Shelter Project. The court voted to advertise for two more weeks.  
Three bids were received for the Lovers Lane Bridge project. Those bids will be reviewed more thoroughly

and presented to magistrates for approval at a future meeting.  
A bid from D & R for fuel for the county was approved.  
A bid from Haydon Materials for asphalt, and stone will be reviewed and presented for approval at a future meeting.  
A bid for road salt was received from Magic Salt and accepted by the court. The bid was \$140 per ton delivered for the salt currently used by the road department or \$195 per ton of an improved Magic Salt that works at lower temperatures and requires less re-salting of roads that don't clear with the initial spread of salt.

The Sheriff's Office had four unclaimed found items that were sold to the highest bidders. Two Honda 4-wheelers sold at \$650 and \$850 and two kayaks that sold for \$37 each.  
The magistrates reviewed the streets in Raywick for possible adoption by the county. A question was raised about the naming of the streets and any possible confusion for EMS, the sheriff's department, and the fire department. The adoption of the streets was tabled until this issue could be looked into.  
The next meeting of the fiscal court will be Thursday, May 1, at 4 p.m.
