# Tower to be erected on Holy Cross knob

Rowan's Knob in Holy Cross was the topic of discussion at the December 4, Marion County Fiscal Court meeting. Representatives from Nelson County answered questions from another supplier to equip the magistrates on a proposal to place a radio tower at the top of the knob which is located on the county line.

He assured magistrates this would be at no cost to Marion County and the county would District 4 Magistrate Jackie Fogle that the project would not disturb the cross or the old church foundation at the top of the knob which bear great significance to

the residents of the Holy Cross Daugherty reported to magistrates

Marion County garbage trucks will soon be equipped with cameras. After a previous agreement fell through, the Marion County Fiscal Court approved an agreement with trucks.

The court approved a proposal to have 360 degree camera coverage around each truck and a camera on the driver's area. The county has received a grant of \$10,000 to help offset the \$24,800 be able to utilize the tower as total cost of equipment and well in the future. He also assured installation. Magistrates also approved a monthly service contract for \$300 per month for the cameras and video streaming system.

Lincoln Trail Area Development District. Daugherty informed the court that the county invests 38 cents per resident in the ADD to support various projects. He said Marion County has received \$2,887.32 per resident in return through various ADD programs.

In other business the court approved the renewal of the contract with Ryan Burdette to provide IT services to the county.

Magistrates also approved reimbursement to the Raywick Fire Department for the truck that was lost in the accident earlier this year. The insurance on the truck was through the county and a check has been issued to the court by the insurance

Sheriff Ray Gardner presented regarding investments in the his proposed budget for 2026 to the court for approval. Magistrates will review the budget over the next two weeks and will discuss it with questions and possible revisions at the next court meeting on December 18.

> An attendee of the meeting, Corydon Moffitt, questioned the process, perceiving that the budget was being handled out of sight of the public and should have been discussed at Thursday's meeting.

> The county attorney explained the process to Moffitt and that it would be discussed at the next meeting after magistrates had an opportunity to review it thoroughly.

Moffit also expressed concerns on other community issues.

### Lawson has pretrial diversion revoked, felony sentence imposed

After hearing testimony from a Drug Court employee, Judge Todd Spalding revoked the pretrial diversion of Brandon Lawson during the Dec. 4 session of Marion Circuit Court Division 1.

Spalding ruled that Lawson violated the terms of his pretrial diversion by being terminated from Drug Court and imposed the felony sentence. Lawson's final sentencing was set for Dec. 18 at 9:00 a.m.

Groves pleads guilty

Alyssa Groves entered a plea of guilty and was sentenced on the following charges: four counts of first-degree wanton endangerment (3 years pretrial diverted for 5 years on each count), first-degree criminal mischief (3 years pretrial diverted for 5 years), two counts of third-degree terroristic threatening (12 months probated for 24 months on each count), and fourthdegree assault-no visible injury (12 months probated for 24 months). All counts will run concurrently.

Spalding ruled that Groves must report to Probation & Parole and follow their recommendations, have no violations of the law, no use of drugs or alcohol, no use/possession of firearms, and must pay restitution to Lebanon Housing of \$1,062.60 at the rate of \$100 a month.

Other cases:

 Joseph Thompson was sentenced to 5 years probated for 5 years on the charge of a convicted felon in possession of a firearm, and 5 years probated for 5 years for thirddegree assault-police/probation officer.

 Christopher Yocum was sentenced to 5 years probated for 5 years on the charge of second-degree strangulation (domestic violence-related), subject to certain conditions, including having no contact with the victim or her children.

# Judge recuses himself from Parman case

A man charged with rape and sexual abuse of a minor will have a new judge

preside over his trial. William Parman appeared in Marion Circuit Court Division 2 on December

4 for a hearing on a motion for recusal of Judge Kaelin Reed and the appointment of a special judge, which was requested by Commonwealth Attorney Kyle Williamson.

Parman is charged with two counts of first-degree rape, victim under 12 years of age, and first-degree sexual abuse, victim under 12 years of age.

Judge Reed recused himself from the case and will enter the order for a special

judge. Parman, 37, of 152 Royal View Drive, was indicted by a November Grand Jury, which charged that the two rape events occurred sometime between the dates of June 30, 2023, and June 12, 2025. The grand jury charged that the sexual abuse occurred sometime between Jan. 1, 2019, and June 29, 2025.

Parman appeared in court on Nov. 20,
