Carmel has been going whole hog with it since the 1990s. The population is only about 100,000. Carmel was named the second wealthiest city in the Midwest. The city is very affluent and they chose roundabouts in their highway construction.

Will lived in Noblesville, another suburb of Indianapolis, same thing. Roundabouts everywhere. Will and wife Stephanie recently moved to another suburb called McCordsville. Same thing.

I figured Will would be a good person to ask why roundabouts are used to replace the traditional stop and go red lights we're so used to. Here's what He told me:

"Roundabouts are generally designed with improving safety and traffic flow in mind."

"A crash diagram of a typical signalized intersection (red lights) has 32 potential crash incident locations, including head on and angle (T-Bone) crashes. Vehicles can enter these (red light) intersections at high rates of speed depending on what the posted speed limit for that roadway

"Roundabouts force the driver to slow down when entering the intersection.

The counterclockwise traffic pattern lowers the theoretical potential crash incident locations from 32 to 8, which include only sideswipe and rear end crashes (both theoretically at lower speeds). At the end of the day, these designs can be great benefits to travelers when used properly. In the instance of a crash, I would rather get a call from a family member or friend with a damaged rear end then get a call from the

coroner stating a member

was hit head on."

I'm not certain how many deaths we have had at our intersections like Highway 555 and 150, Highway 150 and Bloomfield Road or even Highway 555 and Lincoln Park Road but I know there have been some and a lot of other accidents there as well. If we had had roundabouts there is a possibility the deaths would not have occurred and some of the non-lethal accidents as well.

I'm rounding the corner

to 70 in a few years and I don't really like change but it didn't take me long to manage roundabouts when Cindy and I visited Will and Stephannie.

Also, if it wasn't a good idea then why do the rich folk of Carmel, who have used them for over 30 years and have over 150, not push back and quit installing them. Instead, again, they have embraced roundabouts whole hog.

Browning pleads not guilty James Browning pleaded not guilty to two counts of first-degree sodomy, victim under 12 years of age, first-degree sexual abuse, victim less than 12 years of age, intimidating a participant in a legal process, and first-degree wanton endangerment. Browning had a pretrial conference set for Jan. 22, 2026, at 1:00 p.m., and a jury trial scheduled for April 28, 2026, at 8:30 a.m.

Blanford pleads not guilty Charles Josh Blanford, 45, the man accused of four counts of first-degree rape, entered a plea of not guilty and had a pretrial conference set for Feb. 5, 2026, at 1:00 p.m. and a jury trial scheduled for April 28, 2026, at 8:30 a.m.

Blanford and his father, Charles W. Blanford, 73, both of Loretto, were indicted by a November Grand Jury. The vounger Blanford was indicted on four counts of first-degree rape, four counts of first-degree sodomy, and four counts of firstdegree sex abuse.
