September. Throughout the course of the month, I stayed busy working on projects to move Lewis County toward a bright future. As always, I was blessed to meet with a lot of great people, share ideas, and learn new things.

First up, I met with Destiny Conner, Reentry and Employment Service Navigator, at the Lewis County Public Library. Destiny will be set up at the library from 11:30- 1:30 on the first Tuesday of each month. She will be available to help Lewis County residents with resume writing, interviewing skills, job searching and many other services. She is dedicated and ready to serve our community. Next, I met with Tracey Miller, professor at the UK Department of Landscape Architecture/ Martin- Galton College of Agriculture, Food, and Environment. She brought her class of approximately 30 students to Lewis County to look at several projects related to tourism and outdoor recreation. Brian Storz of the KY Division of Water met with us, along with a long list of community partners and leaders Mr. Ben Collier organized. Dr. Miller and her students will work on projects throughout the semester to share with us. While they were in town, we showed the students around Vanceburg and Lewis County so they could ask questions and brainstorm potential ideas for our area. These students are in their second year University Kentucky and are very interested in this opportunity to help our county make the most of our great resources. I am very excited for the group to share the thoughts, ideas, and designs they have put together!

I met with staff from Fresh Start Health Center and the Lewis County Health Department to discuss Recovery Ready Community Centers. These centers offer support programs that help those who gotten off course in life. They help people with support in educational opportunities such as earning a GED, resume writing, and interview skills to name a few. We have been working to-

We hit the ground running in come a Recovery Ready Community (RRC) through the Office of Drug Control Policy. We have made great progress toward being named a RRC. So far, only 29 out of 120 counties have been earned this title. We hope to be added to that list!

Back at the office. I met with my staff to develop and apply for the KACo Insurance Grant. The grant must be related to reducing the risk of injuries that our insurance policy may cover. I worked with Morgan Cooper who prepared and submitted the grant after Fiscal Court approved us to apply.
