CFP dates, times locked in; Rose Bowl moves up one hour

The College Football Playoff announced game times for the 2026 quarterfinals and semifinals and the national championship game on Tuesdav.

The CFP championship, to be played in Miami Gardens, Fla., will be played on the third Monday in January for the second straight year, Jan. 19, with a 7:30 p.m. ET

kickoff.

The quarterfinals will be split between New Year's Eve and New Year's Day. After the Cotton Bowl is played Dec. 31 at 7:30 ET. Jan. 1 will see a tripleheader of the Orange Bowl, the Rose Bowl and the Sugar Bowl.

Notably, the Rose Bowl kicks off at 4 ET/1 PT, one hour earlier than it's traditionally played. Famous for its midgame sunset over the stadium, the game's new time means

the sunset may occur much later in the game, or after the game ends altogether.

The Orange Bowl will kick off the tripleheader at noon ET, and the Sugar Bowl will begin at 8 ET.

The Fiesta and Peach Bowls will take their turns as semifinal hosts in 2026. The Fiesta Bowl will be played Thursday, Jan. 8 at 7:30 ET, and the Peach Bowl will come Friday, Jan. 9 at the same time.

RIVALRY MVPS

The players and coaches who made the most dramatic impact on our state's marquee college sports rivalry in 2024-25 were:

• Kentucky's men's sports rivalry MVP: Lamont Butler, basketball. In his only career appearance in the Cats-Cards grudge fest, the ex-San Diego State point guard played the game of his life. In UK's 93-85 win over U of L, Butler hit 10 of 10 shots, all six of his 3-point tries, and scored a career-high 33 points.

• Louisville men's sports rivalry MVP: Isaac Brown, football. The freshman running back carried the ball 26 times for 178 yards and two touchdowns as the Cardinals smoked Kentucky 41-14.

• Kentucky women's sports rivalry MVP: **Emory Donaldson**, softball. Against her

vated Memorial Coliseum 3-1 over Kentucky.

• Kentucky rivalry coach of the year: Kenny Brooks. In his first UK-U of L meeting, Brooks led the No. 20 Wildcats to a 71-61 overtime victory over the No. 18 Cardinals before a sellout crowd in Memorial Coliseum. For Kentucky, it snapped a seven-game losing skid vs. Louisville.

• Louisville rivalry coach of the year: Jeff Brohm. The second-year Cardinals head man directed the Cardinals to a 41-14 spanking of Kentucky, a win that snapped a five-game losing streak for the Cards vs. the Cats.

• Baseball: Louisville has won 14 of the past 19 meetings vs. Kentucky, although the Cardinals advantage is only 4-3 over the past five seasons. • Basketball: Kentucky

has won 14 of 17. • Football: Even with

this season's loss, UK has won six of the past eight.

• Soccer: After Louisville's 1-0 win at Kentucky ville has beaten Kentucky seven times in the past eight meetings.

• Soccer: U of L has won the past two meetings with UK, although the teams have now inexplicably gone six years without playing.

• Softball: Kentucky has won 12 of the past 14.

• Swimming: UK has won five of the past eight head-to-head meets with U of L, but the Cardinals have won the past two.

• Volleyball: Louisville has won four straight over Kentucky.

THE RIVALRY'S BIG QUESTIONS

Looking forward to 2025-26 in the Cats-Cards rivalry, here are four things to watch:

• Will new Louisville women's volleyball coach Dan Meske continue the Cardinals' recent mastery over Kentucky?

• Can Brohm and U of L football back up their streak-busting win over UK this past season by defeating the Wildcats at the venue now known as L&N Federal Credit Union Stadium for the first time since 2015?

• In women's basketball, can Brooks and UK make it two in a row over Louisville by besting the Cardinals at the KFC Yum Center for the first time since Dec. 7, 2014? • Will U of L men's basketball get Kelsey on the board in the Kentucky-Louisville series by beating UK at the Yum Center - or will Pope seize immediate control of the rivalry by winning in his first try as Kentucky head man on Louisville's home floor?

PUBLIC HEARING NOTICE PROPOSED PLAN TO CONTINUE AND RE-ESTABLISH THE DOWNTOWN LEXINGTON MANAGEMENT DISTRICT

Notice is hereby given that the Lexington-Fayette Urban County Government ("LFUCG") will conduct a public hearing on the 8th day of May, 2025 at 6:00 p.m. in the Council Chambers. 2nd Floor. Government Center. 200 E. Main St., Lexington, Ky., to receive public comment on a proposal to continue and re-establish the existing "Downtown Lexington Management District" (the "District") through the adopting of an ordinance pursuant to KRS 91.750, et seq. This proposal is based upon LFUCG's receipt of a petition from the property owners within the District which meets the minimum requirements of KRS 91.754. LFUCG has authorized the public hearing as a required step in consideration and possible adoption of a proposed ordinance continuing and re-establishing the manage-ment district in a designated area of the Downtown of Lexington, Ky. If the ordi-nance is adopted as proposed, the taxable properties within the District would continue to be subject to an additional assessment not to exceed \$.10 of \$100 of their assessed property value in return for the providing and financing of economic improvements that specially benefit the properties within the District This is the same assessment that currently exists for taxable properties within the District. If the District is reestablished, LFUCG shall not decrease the level of publicly funded services in the District existing prior to its creation or transfer the burden of providing the services unless the services at the same time are decreased throughout the entire urban services area or the urban county. The proposed District is the same as currently exists, which is a contiguous area of approximately 178.62 acres (0.279 square miles) and is encompassed within the map which can be viewed at in its entirety at https://dlmd.org/resources/. The proposed ordinance provides for the boundaries of the District, the re-establishment of a 15 person board to oversee the operations of the District, the powers of the Board including undertaking economic improvements within the District, a July 1st fiscal year, a budget and audit process, an affirmative action plan, public information, an assessment not to exceed \$,10 of \$100 of the assessed property value for each taxable property within the District, a contesting and appeal process, liens, an annual report to property owners within the District, termination of the District by no later than July 1, 2035 unless re-established, ethical requirements, Board guidelines, contracting requirements, management, marketing, administration, and reporting requirements of the District, an advisory Council to the Board, and related matters.
