# Local expert shares budgeting tips amid SNAP uncertainty

The GOP's "big, beautiful bill," is being considered by the Senate after winning passage in the House last month. The House version of the bill includes billions of dollars in cuts to the Supplemental Nutrition Assistance Program, or SNAP, and the McCracken County Extension office is offering money-saving advice for local recipients.

The 1,000-page One bill is a budget reconciliation that would provide roughly \$3 trillion in tax cuts that national news outlets have reported would mainly benefit the wealthy. The bill aims to extend provisions of Trump's 2017 Tax Cuts and Jobs Act that are set to expire at the end of this year.

In May, the nonpartisan Congressional Budget Office estimated that the measure would "take food assistance away from roughly 3.2 million adults in a typical month." According to the Kentucky Center for Economic Policy, under the bill, the state would have to pay a minimum of 5% of SNAP benefits, which could be more than \$600,000 a year.

While McCracken County Cooperative Extension Office Senior Nutrition Education Program Assistant Stephanie Caldwell said she couldn't comment on the bill itself on Monday, she noted that any time someone loses SNAP benefits, it can negatively impact their monthly budget.

Caldwell said the biggest impact would be families having to spend more out of pocket on groceries. SNAP benefits are based on household size, which means each recipient is allocated a different amount Caldwell said a family receiving up to \$600 in SNAP benefits will be subjected to pay more out of pocket than someone receiving \$20. You can't just put a number on any of those, because we have seniors that are [on a] very limited income,' Caldwell said. "Then vou may have a household with five family members, and you have three little children under and a mom and a dad. Then that could be

you're losing those benefits."

According to the Kentucky Cabinet for Health and Family Services, there are 562.619 SNAP recipients in the state. In west Kentucky, there are 23,041 SNAP recipients, with McCracken County having the highest number at 7,605.

To prepare for the possibility of losing SNAP benefits, Caldwell encouraged families to become "savvy shoppers." She said meal planning is the best way to make use of SNAP benefits, and encouraged people to cut out convenience food options to save money.

For SNAP recipients who eat chicken, Caldwell advised buying whole chicken instead of cutlets. She said to purchase a variety of beans, rice, vegetables and fruits, explaining that the objective is to purchase foods that could be used across a variety of meals. She also stressed the importance of planning before making a trip to the and trying to get help, to his desk by July 1. store.

As you go to the grocery store, if you walk in without a plan, you come out with a lot more food than you need, [and] a lot more money than you've actually wanted to spend, sometimes,' Caldwell said. She advised cutting out convenience foods "because when you're using convenience foods, pre-cut, pre-packaged, frozen things like that, those can be just one-time meals. A frozen pizza

very limiting whenever sounds like a fun time on a Friday night, but not for your whole week of your groceries when that's one meal."

Jensey Blackwood is a mother of two and was once a SNAP recipient who received close to \$700 in benefits for food. Of the proposed SNAP cuts, she said, "I think it's going to be awful for a lot of people."

She said in the past she dealt with her SNAP benefits being cut slightly when she received raises from her employer. She encouraged people to educate themselves about SNAP and volunteer at local food banks to get a sense of the food insecurity in their area.

"I think people have a preconceived notion of what people who are on food stamps are like. and I don't think that that's the truth," Blackwood said. "I think that if people went and saw the people, the types of people, the different groups that are coming to these food banks
