

JAILHOUSE BLUES ARE NEARING A CONCLUSION

In what was called

a "momentous" occasion for McCreary and Whitley Counties, state and local officials from both counties took part in a groundbreaking ceremony for the \$10 million, state-funded expansion of Whitley County's Detention Center, with work set to start immediately. The facility, located just off KY Hwy 92 before Walmart and Goodwill when heading east from McCreary County, will, once the expansion is finished, house all future McCreary County inmates. The 100-bed expansion incurs no construction costs for

Whitley County Judge Pat White, Jr. served as Master of Ceremonies for last Tuesday's (11-25-25) ground-breaking ceremony, welcoming attendees and introducing speakers includ-ing KY State Police Trooper Matt Ridener (who led the prayer), Whitley County Jailer Jason Wilson, McCreary County Judge Executive Jimmie "Bevo" Greene, KY Senate President and elected Senator for McCreary/Whitley Counties Robert Stivers, and Whitley County State Representative Nick Wilso. Wilson is a former public defender for McCreary County.

Judge McCreary's Executive Greene called the expansion a gamechanger for McCreary County, noting that the current transport drive to Knox County takes approximately one hour and ten minutes.

"This will significantly cut down on the drive time, saving money and making trips safer for both inmates and transport officers," Greene observed. "Additionally, we will now be able to use eligible inmates for supervised work details in McCreary County." Greene continued, noting that it will also be much more convenient and lessen the drive time for family members

when visiting incarcer-

ated loved ones.

Noting that Whitley and McCreary County Fiscal Courts and Judge Executives worked together to secure the project, White said he looks forward to continuing the growing partnership between himself Judge and Greene.

Senate President Robert Stivers played a key role in securing state funding for the project. Both Whitley and McCreary Counties were redistricted into Stivers' 25th state Senate District at different times due to population changes in the U.S. Census.

Whitley "When County was redistricted into my 25th District, I saw there was a need with the jail," Stivers explained, addressing the audience. "When redistricting occurred a second time, putting McCreary County into my District, I learned that McCreary County is without a jail and transports its inmates to places, sometimes, as far away as Leslie and Knox Counties. This plan between the two counties just clicked."

Stivers continued, noting the benefits for both counties, including making the court system run more smoothly, as it will now be easier for attorneys to meet with their clients, and it will be less time-consuming and easier to transport inmates to their court appearances.

"It has taken mayors, judges, the court system, everyone looking at the best way to provide services while, at the same time, keeping citizens protected, in addition to saving money for both counties," Stivers declared. "This is how government should work."

"This is a great partnership," reiterated Representative Wilson. "This is a good day for both McCreary and Whitley Counties."

McCreary's Judge Executive Greene told the McCreary Journal that the only cost to McCreary County from Whitley County will be the state-mandated

per diem, which is currently \$35.34. Greene also stated that Judge White assured him that McCreary will be allocated 100 beds, with more as needed. Greene mentioned that a written contract between the two counties will detail the specifics.

Whitley County's 100-bed jail expansion specifically includes 90 cells with bunks, 10 isolation cells, community space, and indoor and outdoor recreation areas. Codell Construction was awarded the construction bid, with completion expected within 18

Currently, McCreary County inmates are transported to Knox County and housed at the Knox County Detention Center in Barbourville, KY. McCreary County been transporting its inmates for

over a decade since the

Kentucky Department

of Corrections closed the McCreary County jail in 2013, citing multiple facility issues. Those incarcerated at the McCreary County Jail when it closed were moved to the Laurel County Correctional Center. Since then, McCreary County has contracted with several counties, includ-Wayne, Leslie, ing and Knox, to house its inmates.

Jail costs across the Commonwealth have reached a crisis point. Like McCreary County, more than a third of Kentucky's counties lack their own jails; instead, they contract with other counties to house inmates. Since these counties cannot afford to build and maintain their own jails long-term, transporting inmates remains the only

practical option, offering

significant savings for

those counties.

Currently, there are no statewide plans for new jails; instead, much of the focus has shifted to expanding existing jails and establishing regional jails, in which multiple counties in a region share a facility. To build a new county jail, the state must approve, typically requiring at least

150 beds. Whereas the cost of a 100-bed expansion at Whitley County (to include McCreary County) is anticipated at \$10 million, the estimated cost to build a new 100-bed jail for an individual county is between \$25 and \$45 million, depending on location, security level, etc.
