## HOW TO APPEAL FEMA's DECISION

If you receive a letter from FEMA saying you are not approved for assistance, it may just be that we need more information. It's possible that it could be something as simple as a missing document.

Please read the FEMA letter carefully and entirely. If you are found ineligible, the letter will explain the reasons.

If you disagree with any decisions from FEMA, you may appeal.




### The Appeal Process

It is important to include documentation to support your reason for appeal. Provide any information FEMA has requested, such as documents from your insurance company and documents that prove occupancy or ownership.

Be sure to write your FEMA application number and the disaster number (DR-4860-KY) on each page of your appeal to FEMA and on any documents that are submitted.

Mail your appeal within 60 days from the date on your FEMA decision letter to: FEMA - Individuals & Households Program National Processing Service Center, P.O. Box 10055, Hyattsville, MD 20782-8055

You can also upload your appeal documentation to your account on DisasterAssistance.gov, or fax to 800-827-8112.
