Kentucky Infrastructure Authority to meet June 5

The Kentucky Infrastructure Authority (KIA) Board of Directors will hold its regularly scheduled meeting Thursday, June 5, at the KIA office, 100 Airport Road, Third Floor, in Frankfort.

The agenda includes the consideration of minutes from the May 1 meeting and several new funding resolutions. Among new projects requiring board action are:

- Resolution and Order of the Board of Directors Authorizing and Approving the Issuance of Obligations of the Kentucky Infrastructure Authority to Reimburse Capital Expenditures made by Governmental Agencies Pursuant to Loans made by the Kentucky Infrastructure Authority to such Governmental Agencies
