## E'town couple will not face the death penalty in homicide

An Elizabethtown couple pleaded not guilty to murder after a grand jury indicted them on the charge for reportedly throwing a man over a balcony, killing him.

Shawn Durbin, 39, and Nancy Durbin, 36, appeared Tuesday by Zoom in Hardin Circuit Court, where Judge Larry Ashlock warned the couple they could face the death Following the brief appearance, Assistant

Commonwealth's Attorney Chris McCrary said the Durbins likely won't face the death penalty for the capital charge.

McCrary said the Durbins could only face the death penalty if aggravating circumstances existed in their case.

"If aggravating circumstances existed, the Commonwealth can file notice of seeking aggravated sentences," McCrary said. "I'm not aware of any aggravating circumstances at this time, and the Commonwealth has not filed any notice to seek an aggravated sentence at this time.'

According to Kentucky Law, aggravating circumstances include when the victim is a police officer or public official killed

in the line of duty; murdering someone for financial gain or hiring someone to commit murder; murdering someone during another felony such as a robbery, rape, arson

## Radcliff to sell former FFO property

The City of Radcliff is putting the former FFO building up for sale.

All information is expected to be ready by the end of this week, early next week to list the property.

Appraisal of the property came in at \$800,000.

"The council has decided that we're going to do a sealed bid," Mayor J.J. Duvall said. "We hope to be closing that sometime in February.'

There will be a reserve on the building of \$500,000, meaning in order to be considered, bids must meet that

minimum. Once information on the property is released, with signage placed on the front of the building, and on the city's website, the city will accept sealed bids until the end of January.
