# Storm brings 'death, injury and untold damage'

n Friday, Jan, 19, 1924, one of the most severe storms that the people of Campbellsville could recall plagued Taylor County.

According to the Central Kentucky News *Journal*, the storm started at 4 p.m., "leaving in its wake, death and injury and untold damage to property in both the county and the

Countless homes experienced damage to their roofs. Barns were damaged and outbuildings were blown away. Trees and telephone poles were "mown down like weeds," according to the paper, including some 25 or more telephone poles that blew down along the road between Campbellsville and Lebanon.

Large trees fell — some snapping in two, while others were totally uprooted — many landing on homes and other buildings. Streets were strewn with broken limbs and debris. The storm was accompanied by a downpour of rain which compounded the wind's damage. The storm never was classified as a tornado, but the devastation was widespread.

The storm caused lights to go out for several hours, but power quickly was restored by Kentucky Utilities, according to reports. Telephone service was likewise interrupted.

One death occurred during the storm when the home of Mr. and Mrs. C.M Williams began to collapse and the bricks fell on the crib of 7-month-old Nellie Catherine. Their 3-year-old daughter was also in the room but escaped injury. Their small house located on the Harry Edwards farm (known as the Hiestand Place) was demolished.

In the Shiloh area, Arthur

Antle was working in the barn of his father, Martin Antle, when the storm struck. He attempted to get back to the house when

> a flying tree limb struck him, causing near fatal injuries.

According to the paper, the area hardest hit by the storm was the Friendship Pike area, citing countless "unpleasant and gruesome sights" seen following the storm – including a vast loss of timber, shade trees and

orchards.

Six days after the storm, the Jan. 24th newspaper published a long, yet incomplete, list of storm damages reported to them:

- Charles Cowherd had a barn destroyed and two sheep killed.
- Walter and Russell Shipp lost a barn, two horses and a
- Barney Kearns' house was "wrecked" with all windows blown out, and his barn destroyed.
- The Fairview School house was unroofed and "twisted" off its foundation.
- P.C. Rose's house was unroofed and his barn and crib were badly damaged.
- Clyde, Ira and Floyd Read lost their barn, had significant damage to their house and both their garage and meat house were blown away, causing them to lose a large quantity of meat.
- Lee Read on Friendship Pike had his residence and store destroyed.
- Mrs. Edgar Perry lost a large quantity of timber.
- George Van Cleave had damage to his house and three outbuildings. He likewise reported that the creek that ran through his property had completely changed its course due to rooted trees blocking the original channel.

- John Gilpin's house had a severely damaged roof.
- Charlie Parrott had one barn destroyed and one damaged.
- Thomas Stone's barn was destroyed.
- In the Smith's Chapel neighborhood, Fountain Cox had a 40- by 70-foot barn blown off its foundation.
- Harrison Smith, living on the property of J.H. Burress, sustained damage to his log house when his roof was blown off along with the top logs of the second floor.
- J.T. Lovelace on Friendship Pike had both house and barn
- Mrs. Less Coontz of the same neighborhood had a barn
- James Phillips sustained the loss of a large tobacco barn and timber, estimated at \$2,000.
- W.W. Kerr had a barn and outbuildings damaged.
- Clarence Anderson of Shiloh had his barn and crib destroyed, one horse killed and one crippled.
- Dick Parish, living on the Eugene Blakely farm, sustained loss to his house, garage and outbuildings.
- Fred Faulkner had two barns damaged.
- A.D. Strader, who lived two miles from town on the Lebanon Pike had a barn unroofed.
- The Taylor County Fair Association property sustained heavy damages. Fences were leveled, stables and sheds were damaged and the grandstand had been moved off its foundation. Damage was estimated between \$1,000 and \$1,200.
- Eugene Rice lost two barns and a double corn crib, with an estimated lost of \$600 to \$700.
- Mac C. Goode's outbuilding loss was estimated at \$100.
- F.B. Netherland's loss to his house and outbuildings was estimated at \$200 to \$300.

- Joe B. Gaddie had several barns and outhouses damaged and destroyed.
- Omer Stone's house and two barns were wrecked.
- Bennie and Noah Smith had one barn wrecked and another damaged.
- Allen R. Keltner of Shiloh lost two large barns, one of which contained fine farm machinery, now in ruins. His house was badly damaged and his total loss was said to run \$3,000.
- Mr. M.M. Antle, whose son was seriously injured by the storm, also lost a barn with a quantity of tobacco and numerous farming machines.
- Mrs. R.D. Burress' property and house occupied by Mr. L.W. O'Banion was demolished at a loss of \$3,000, along with his many stately forest trees. Mr. O'Banion also sustained a heavy loss of household goods, damaged by the rain.
- W. Hazelwood lost a barn, mule and horse.
- J.H. Wooldridge had a barn partly unroofed.
- Mr. Charles Karnes lost a barn and car and had a horse and valued sow injured. Karnes was in the barn at the time of the storm and was slightly insured.
- J.D. Edwards had his crib unroofed and a barn blown off its foundation, plus a lot of timber damage.
- George and Leonard Phillips of Bengal lost a tobacco barn and tools.
- James Cowherd had his house unroofed and two barns badly damaged.
- The residence of the late Henry Bland of Fairview was unroofed and his barn damaged. The storm likewise wreaked

havoc within the city limits, doing extensive damage to shade trees, orchards, outbuildings, roofs and chimneys. Early damage reports in the city were:

- A large black sugar tree blown down across the residence of Dr. W.B. Adkinson, causing damage to the front part of the house and porch.
- The residence of Mr. R.B. Wilson was partly unroofed and a newly built poultry house was overturned.
- The residence of Paul Johnson on Lebanon Avenue was partially unroofed.
- The residence of John McKenty on Lebanon Avenue was partially unroofed and several trees were uprooted.
- Mr. E.W. (Petey) Willock sustained considerable damage to his billboards near town.
- L.E. Darnell lost two chimneys from his residence and sustained damage to his orchard and shade trees.
- The Willock Building on Main Street lost many of their glass windows.
- A large section of the roof of Lerman Brothers was blown • C.M. Durham on Central
- Avenue had glass windows of his residence blown out and his outbuildings were damaged. • The Taylor County High
- School building had damage to its glass windows.

In closing, the News Journal stated that damage from the storm was so widespread that it was impossible to gather all the details of all the destruction Taylor County had endured.

At a time when very few people had insurance, the paper estimated the total damage already reported would exceed \$100,000 — or more than \$2 million in today's economy.
