ORDINANCE NO. 1, SERIES 2025 AN ORDINANCE RELATING TO SOLID WASTE COLLECTION AND DISPOSAL SERVICES IN THE CITY OF BEDFORD, KENTUCKY AND FIXING THE CHARGES, RATES AND REGULATIONS RELEVANT THERETO

WHEREAS, the City Commission of the City of Bedford, Kentucky has received and reviewed bids and accepted the bid re ceived from Rumpke of Kentucky, Inc., to provide garbage collec ion and disposal services within the City of Bedford; and

WHEREAS, due to the increasing costs of providing garbage ollection and disposal services, the City Commission of the City of Bedford finds it necessary to increase the fees charged to roperty owners within the City of Bedford for such services; and WHEREAS, the City Commission of the City of Bedford finds it ecessary to enact this ordinance to consolidate and establish all egulations relevant to garbage collection and disposal services

NOW THEREFORE, be it ordained by the City of Bedford, Kentucky:

SECTION 1. GARBAGE COLLECTION AND DISPOSAL SER-VICES PROVIDER.

Except as provided in subsection (b) of this section, all own ers of improved real estate and the operators of businesses within the city limits of the City of Bedford, Kentucky shall utilize the garbage pickup and disposal services of Rumpke of Kentucky , (hereinafter referred to as "Rumpke"). This Ordinance shall not apply to industrial business operat

ors or commercial enterprises which reasonably require a dumpster for the disposal of garbage. Such persons may contract with any qualified entity they desire for the collection of refuse garbage, or industrial waste, unless otherwise provided by ordin ance of the City of Bedford.

SECTION 2. SERVICE CHARGES AND FEES.

(a) The City of Bedford, which shall pay Rumpke for the garbage collection and disposal services it provides within the turn collect fees from owners of real estate operators of businesses to whom this Ordinance applies for such services as follows for the time periods listed below:

January 1, 2025 - December 31, 2026: \$13.50 per month.

(b) The service fee set forth in subsection (a) of this section shall include one (1) time per week collection of the contents of one (1) 96-gallon trash cart, provided by Rumpke, and collection of one (1) large and/or bulky item.

(c) Where appropriate, Rumpke may arrange for additional ser vices to be charged directly by Rumpke to the customer.
(d) There shall be no proration of fees for any partial month

Customers shall be responsible for the entire bill for any partial month in which service is provided. (e) In addition to the service fee set forth in subsection (a) of this section, the City of Bedford shall charge owners of real es-

tate and the operators of businesses to whom this Ordinance ap-plies an administrative fee of \$2.50 per month to offset the costs incurred by the City in the administration of this garbage collection and disposal service. (f) The fees and charges set forth in this Ordinance may be

amended from time to time as necessary to address increases in the costs associated with providing garbage collection and disoosal services.

If the 10th day of the month is a Saturday, Sunday or a legal holiday, payment shall be deemed timely and not delin quent if it is made on or before the next day which is not a Sat

paid after the 21st day of the month. Service shall not be reactiv ated for such accounts until the outstanding balance, including all penalties, is paid in full.

If 30 days after an account becomes delinquent the account has still not been paid in full, the City of Bedford may pursue leg-al action in a court of competent jurisdiction to collect any unpaid fees, charges, and penalties imposed by this Ordinance and the legal fees it incurs in pursuing such action.

(f) For purposes of this Ordinance, the owner(s) of residential rental property shall be deemed to have ultimate responsibility for payment of the fees imposed by this Ordinance regardless of any arrangement or agreement between the owner(s) and their ten ant(s) under which the tenant(s) is to bear responsibility for such
