Williams earned a spot on the American Athletic Conference All-Freshman team after averaging 9.3 points, 4.5 rebounds, 1.3 assists, 1.4 blocks and 1.1 steals.

Quaintance was a consensus five-star prospect and a 2024 McDonald's All-American who originally signed to Kentucky before John Calipari left for Arkansas. Quaintance instead went to Arizona State where he started all 24 games he played. Quaintance, who turns 18 this summer, averaged 9.4 points, 7.9

Jelavic played for Mega Superbit, a team from

While Lowe and Dioubate are moving to Lexington, former Xavier guard Ryan Conwell is heading about an hour west to Louisville.

The rising senior is joining the Cardinals following an impressive season in which he was named to the All-Big East third team after averag-

ing 16.5 points, including a career-best 38 against Marquette in the Big East Tournament. Conwell finished in the top 10 in the Big East in 3-point percentage (41%), field goal percentage (45%) and free-throw percentage (83%).

Louisville is Conwell's fourth stop in as many seasons. He previously played at South Florida and Indiana State before joining Xavier.

FOR THE PROPERTY TAX ASSESSMENT ROLL

The TRIMBLE County real property tax roll will be opened for inspection from May 5 through May 19, 2025. Under the supervision of the property valuation administrator (PVA) or one of the Deputies, any person may inspect the tax roll.

This is the January 1, 2025, assessment on which state, county and school taxes for 2025 will be due about September 15, 2025

The tax roll is in the office of the Property Valuation Administrat-or and may be inspected between the hours 8:30 am and 4:30 pm Monday through Friday, except for 12:00 pm until 12:30 pm when the office is closed for lunch. The office will also be open on Saturday May 10th and May 17th from 8:30 am until 12:00

Any taxpayer desiring to appeal an assessment on real property made by the PVA MUST FIRST REQUEST A CONFERENCE WITH THE PVA. THE CONFERENCE MAY BE HELD PRIOR OR DURING THE INSPECTION PERIOD. WRITTEN DOCU-MENTATION SUPPORTING YOUR OPINION OF VALUSE WILL BE REQUIRED.

Any property owner still aggrieved on real property, after the con ference with the PVA or designated deputy, may appeal to the County Board of Assessment Appeals.

The appeal must be filed with the county clerk's office no later than one workday following the conclusion of the inspection period.

Any property owner failing to appeal to the county board of assessment appeals, or failing to appear before the board, either in person or by designated representative (see KRS 133.120), will not be eligible to appeal directly to the Kentucky Board of Tax Appeals.

Appeals of PERSONAL PROPERTY assessments SHALL NOT be made to the County Board of Assessment Appeals. Personal property taxpayers shall be served notice under the provisions of KRS 132.450(4) and shall have the protest and appeal rights granted under the provisions of KRS 131.110.

The following steps should be taken when a taxpayer does not agree with the assessed values of personal property as determined by the property valuation administrator.

(1)Taxpayers must list under protest (for certification) what they believe to be the fair cash value of their property. (2)Taxpayers must file a written protest directly with the Department of Revenue, Office of Property Valuation within 30 days from the date of the notice of assessment. (3) This protest must be in accordance with KRS 131.110. (4)The final decision of the Department of Revenue may not be appealed to the Kentucky Board of Tax Appeals.
