County EMS urges water safety

Launches 'Water Watcher' initiative as pool season starts

LA GRANGE — With the end of the school year in sight, kids are counting down the days until swimming pools are open for the summer. For many of them, the wait ends this weekend.

As families get ready for summer fun, Oldham County EMS wants to remind parents that without proper safety precautions, pools can be dangerous, especially for small children. According to the Centers for Disease Control and Prevention (CDC) drowning is the number one cause death for children 1-4 years old in the United States.

Last summer, Oldham County EMS responded to two drownings involving children under the age of four. For Maj. John Luker, the operations officer for Oldham County EMS, that was two calls

you never want to see happen," Luker said.

The 36-year veteran paramedic has responded to countless calls involving young children over the years. He knows the heartbreak of those calls, and he knows how easily they can be prevented.

"Adult supervision is the most important way to prevent drowning. Most parents know that. But at a family gathering or party it's easy to get distracted and suddenly no one is watching the kids," Luker said. "There needs to be one designated adult assigned to supervising, because when there's a group, everyone thinks someone else is watching the kids."

"WATER WATCHER" INITIATIVE

Inspired to find a solution, Luker came across "Water Watcher" lanyards from the U.S. Consumer Product Safety Commission (CPSC) and brought the program to Oldham County. His goal is to dis-"That was tough for our tribute as many as possi-

The lanyards are a physical reminder of who has been designated to supervise children. If that person needs to be relieved for any reason, the lanyard is handed off to another responsible adult to ensure someone is always giving their full attention.

The lanyards outline best practices to prevent drowning, such as regularly scanning the bottom of the pool, avoiding distractions, and keeping a phone close to call 911 in an emergency.

CPR SAVES LIVES; FREE CLASS AVAILABLE

In addition to having a designated supervisor, Luker recommends swimming lessons for kids and CPR training for all adults especially if you have a pool at home.

We've noticed that a lot of drownings can occur when a child is visiting someone else's pool. For example, the homeowner's family may all be strong swimmers, but a friend coming over might not be," Luker said. "If at least one adult on site knows CPR, they can keep a child alive until help arrives.'

Commission begins budget approval process

The Crestwood City Commission conducted the first reading of its proposed budget for the upcoming fiscal year, spanning from June 30, 2025, to July 1, 2026.

Mayor Jim Kramer presented the most notable differences between the current and upcoming budget, saying that the city expects a total revenue increase of \$500,000 due to insurance premiums and rental

Rental incomes would have been higher, Kramer said, if the Oldham County Court system did not plan to move from its temporary location in Crestwood to the freshly renovated courthouse in La Grange in the coming months.

In expenses, the most notable difference is a \$500,000 increase in property maintenance, which is mainly due to the further improvements to the Crestwood Mercantile building that the commission approved a \$667,467 bid for at its last meeting.

Other notable changes are a \$50,000 increase in snow removal, a \$25,000 increase in road maintenance and a \$100,000 increase in memberships and dues.

Kramer said that the increase in memberships and dues will allow for the commission to purchase other memberships with organi-

Cities, for example.

The budget has a forecasted surplus of about \$167,000, Kramer said. In other news, the commission

heard from Oldham County Police Commander Major Scott Wolf, who reported that, during April, there were 432 neighborhood checks. area checks and business checks.

"That means that officers are patrolling through all hours of the day and night, checking neighborhoods and businesses for anything suspicious or out of order that [may require] investigation," said Wolf.

He also reported that there were 19 collisions, 15 of which had no injuries and two of which were hitand-runs. Also, there were seven runs for suspicious persons, five runs for suspicious vehicles and seven thefts reported — one from inside of a vehicle and one theft of a vehicle itself.

 Kramer reported that the city's final past due audit has been submitted, received and accepted by the state.

 Maples Park representative Jody Smiley reported that there are plans to install banners in the downtown area that she hopes to be up by Memorial Day, Allen Lane Band and a car show will be held at Maples Park on May 16 and Arts on the Green will be held at Maples Park on June 14 and 15.

• City Engineer William Marshall reported that, during the excavation to start installing the truck overhead mast arm on the railroad crossing near Maples Park, bedrock prevented digging to the necessary depth and will likely require a new location.

• City Attorney Laura Stoess Regarding vehicle break-ins, Wolf reported that she is working on updating the city's ethics ordinance and that a webinar on ethics will be held at 3 p.m. on June 10.

 Commissioner Joan Bryant reported that she is hoping to schedule a community trash collection sometime during the fall and that the fence rental business may provide fencing for the event free of charge as a public service.

The Crestwood City Commission's next meeting is scheduled for 7:30 p.m. on June 11, where the second reading and public hearing of their proposed budget will be conducted.




