CITY OF ORCHARD GRASS HILLS, KENTUCKY ORDINANCE NO. 2025-01

AN ORDINANCE ESTABLISHING THE LOCATION AND TIME FOR REGULAR MEETINGS OF THE CITY COUNCIL OF ORCHARD GRASS HILLS, KENTUCKY.

WHEREAS, the City Council of the City of Orchard Grass Hills, Kentucky, recognizes the importance of transparency, accessibility, and consistency in conducting public meetings to serve the residents of the City;

WHEREAS, Kentucky Revised Statutes (KRS) 61.820 requires that all meetings of public agencies be held at specified times and places that are convenient to the public; and

WHEREAS, establishing a fixed location and regular schedule for City Council meetings promotes public participation and ensures compliance with the Kentucky Open Meetings Act;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ORCHARD GRASS HILLS, KENTUCKY, DOES HEREBY ORDAIN AS FOLLOWS:

1. The regular meetings of the City Council of the City of Orchard Grass Hills, Kentucky shall be held at the Anchorage-Middletown Fire Station No. 8 located at 9514 Featherbell Boulevard, Prospect, Kentucky, unless otherwise specified by a special resolution of the City Council. In the event that the designated meeting location is unavailable due to unforeseen circumstances (e.g., natural disasters, renovations, or emergencies), the City Council may designate an alternate location by providing public notice in accordance with KRS 61.823.

2. Regular meetings of the City Council of the City of Orchard Grass Hills, Kentucky shall be held on the second Thursday of each month at 7:00 P.M., unless said day falls on a legal holiday recognized by the Commonwealth of Kentucky. If a regular meeting date falls on a legal holiday, the meeting shall be rescheduled to the following business day at the same time and location, unless otherwise determined by the City Council with proper public notice.

3. Special meetings may be called by the Mayor or a majority of the City Council members in accordance with KRS 61.823, with notice provided to all council members and the public at least twenty-four (24) hours in advance. Emergency meetings may be held as permitted under KRS 61.823(4) when immediate action is required, with notice provided as soon as practicable. Special and emergency meetings may be held at the designated regular meeting location or an alternate location, provided the location is accessible to the public and notice complies with state law.

4. All regular, special, and emergency meetings shall be open to the public in compliance with KRS 61.800 el seq., except when a closed session is permitted under KRS 61.810. The City Clerk shall ensure that the meeting location is accessible to individuals with disabilities in compliance with the Americans with Disabilities Act (ADA).

5. This ordinance may be amended by a majority vote of the City Council at any regular or special meeting, provided that the proposed amendment is included in the meeting agenda and public notice is given in accordance with KRS 61.820 and 61.823.

6. If any provision of this ordinance is found to be invalid or unenforceable by a court of competent jurisdiction, the remaining provisions shall remain in full force and effect.

7. This Ordinance shall take effect from and after its passage and approval by the City Council and publication as required by law.

CITY OF ORCHARD GRASS HILLS, KENTUCKY ORDINANCE NO. 2025-02

AN ORDINANCE PROVIDING FOR THE ASSESSMENT OF ALL REAL PROPERTY WITHIN THE CORPORATE LIMITS OF ORCHARD GRASS HILLS, KENTUCKY, AND THE LEVYING OF AN AD VALOREM TAX THEREON FOR CITY PURPOSES.

WHEREAS, pursuant to the provisions of KY. Rev. STAT. ANN. § 92.2890, et. seq. the City of Orchard Grass Hills, Kentucky is authorized and empowered to provide a system for the assessment, levying and collection of all city taxes;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ORCHARD GRASS HILLS, KENTUCKY, DOES HEREBY ORDAIN AS FOLLOWS:

- The following provisions shall apply for the period of July 1, 2025 through June 30, 2026, the fiscal year of the City of Orchard Grass Hills, Kentucky.
- The assessment made by the Oldham County, Kentucky, and the Property Valuation Administrator for the state and county for tax purposes in the City of Orchard Grass Hills, Kentucky. The City Treasurer shall by July 15, 2025, or as soon thereafter as is possible, obtain an appropriate listing from the Oldham County Property Valuation Administrator's books after they have been supervised and corrected by the Oldham County Board of Equalization. Said listing shall include all property located in the corporate limits of the City of Orchard Grass Hills, Kentucky and
- The Treasurer shall add to the above-listed any property not listed on said list.
- The ad valorem tax for the year 2025-2026 is hereby fixed at the rate of seventeen-point seven cents (.77) per one hundred dollars (\$100.00) valuation of property as assessed for taxation. Said tax shall be due and payable by the
 - (a). November 1, 2025 and before: Face amount less discount of five percent 95%);
 - (b). November 2, 2025 to November 30, 2025: Face amount;
 - (c). December 1, 2025 to December 31, 2025: Face amount plus a penalty of five percent (5%); and
 - After January 1, 2026: Face amount plus a penalty of five percent (5%) plus interest at the rate of eight percent (8%) per annum from January 1, 2026 until paid in full.
- After the assessment book are completed in the aforementioned manner, the City Treasurer shall make out the tax bills therefrom. Each bill shall show the lot and improvements and the assessment thereon separately, the name of the owner of record, the Ad Valorem tax rate and the total amount due.
- The City Treasurer is ordered to prepare and mail bills covering said taxes on or before August 15, 2025.
- Upon delivery of such bills, payment shall be made by the City Treasurer. Collection of delinquent taxes shall be made in the manner prescribed by law, including the following protocol:
 - (a). October 15, 2025: First delinquency notice sent with penalty amount;
 - (b). November 15, 2025:Second delinquency notice sent with penalty amount and interest; December 1, 2025: Third delinquency notice sent with amount due and details of impending tax lien; and
 - January 2, 2026: Tax lien to be filed in the Office of the Oldham County Clerk pursuant to Ky. Rev. Stat. Ann. 91A.070(3). Thereafter, the tax lien shall be subject to the foreclosure proceedings set forth in Ky. Rev. Stat. Ann. 91 484 to 91.527. In any such proceeding, the City shall recover its costs and attorney fees not to exceed \$250.00 per hour.
- The proceeds of such taxes are to be used for the general purposes of the City, and the necessary capital expenditures
- This Ordinance shall take effect from and after its passage and approval by the City Council and publication as
