# Heath launches comeback bid for Kentucky House seat

MAYFIELD — Former State Rep. Richard Heath aims to retake his former seat in the general assembly, filing to run in the House District 2 Republican primary in 2026.

Heath previously served as District 2 representative from 2012 to 2025, before he was defeated in the 2024 primary by now-incumbent Rep. Kim Holloway. Holloway has also filed to run in 2026. The district includes Graves County and part of McCracken County.

In a news release announcing his candidacy. Heath said the decision to run came after a lot of careful consideration.

'I have prayed a lot about this, and as a firm believer in the political ideology that you run for office for one of two reasons, to make noise or make a difference," Heath said. I am running to make a positive difference."

Heath said during his previous tenure as District 2 representative he worked to remove "overly burdensome" regulations, including sponsoring legislation that legalized home-based food products, allowing people to sell foods they baked in their homes. Heath said

cess to allow Murray State University to create a veterinary school and worked with then-Agriculture Commissioner Ryan Quarles to "secure a 10% tolerance for trucks carrying poultry, livestock, and other farm products on state roads."

# State Sen. Carroll launches reelection campaign

Republican State Sen. Danny Carroll of Paducah officially announced his candidacy to run for re-election Wednesday, hoping to continue his decadelong career representing Senate District 2.

Kentucky's 2nd Senate District includes McCracken, Ballard, Carlisle, Livingston and Marshall coun-

"Serving the people of Western Kentucky in the State Senate has been the honor of my lifetime." Carroll said in a news release announcing his campaign. "I've seen some remarkable progress take hold in our region. We're creating jobs, lowering taxes, and right now we're positioning our region as a leader in advanced nuclear energy and manufacturing. But the work is never finished, and I'm asking voters for their continued trust to keep fighting for the priorities that matter most to our communities.

Highlighting his record on nuclear energy development in Kentucky, Carroll said he championed bills including a 2017 measure that lifted the state's moratorium on nuclear energy, a 2023 resolution that established the nuclear energy working group, a 2024 measure that

established the Kentucky Nuclear Energy Development Authority, a 2024 resolution directing the Public Service Commission to make all necessary preparations to advance nuclear energy in Kentucky and a 2025 measure that established a KNEDA grant program for projects that advance the nuclear sector.

Other key issues Carroll said he's

education, law enforcement, nuclear energy, economic development and fiscal responsibility. If reelected, he said he will continue to focus on those issues, as well as "conservative values.'

"Western Kentucky is experiencing extraordinary growth," Carroll said in the news release. "From nuclear energy development to advanced manufacturing, we're proving that amazing things can appen when government gets out of the way and empowers people to succeed. I'm running for reelection to ensure we handle these new opportunities with care and keep the focus squarely on how this will benefit our local families who need to put food on the table. We're going to create an even brighter future for our children and grand-

children.' Carroll is currently the chairman of the Senate Families and Children Committee and serves on several other committees, panels and boards, the full list of which can be found online at https://tinyurl. com/54sz27tt.
