SECTION TWO:

The Budget Ordinance shall be administered by the executive authority as prescribed and set forth in the Kentucky Revised Statutes. Administration shall include but is not limited to the following:

A. Preparation and submission of financial statements which include budgetary comparisons on not less than a quarterly basis

B. Provide for budget amendments if requested by the legislative body or if anticipated during the FY

C. Prepare any financial statements required for publication purposes, pursuant to KRS 424 and 91-A

D. Cause each fund of this budget to be audited as prescribed by law

The detailed operating budget is adopted by reference for administration and accounting purposes This ordinance shall become effective immediately upon passage and publication as required by law
