surrounding the shooting have yet to be released. We expect more information from KSP Post 10 soon.

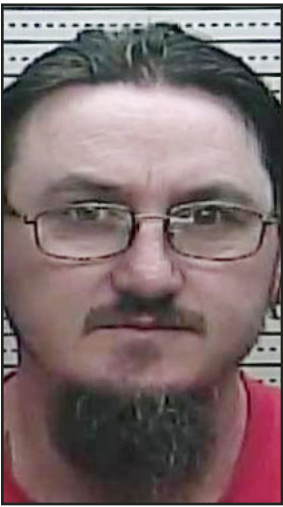
KNOX COUNTY KY ALERT

A short time before 8:00 p.m., Kentucky State Police responded to a call of a gunshot on Binghamtown Road off Highway 223 in the Flat

Lick community.
Once on scene, it was determined a 70-year-old father had shot and killed his 47-year-old son.
Barbourville Police, Knox County EMS, and Knox County Sheriff's Deputies all responded along with the Knox County Coroner.

Cumberland man arrested and charged with multiple sexual offenses against a minor

After an ongoing investigation was initiated by Sgt. Jody Risner and Detective Hunter Luttrell at the Bell County Sheriff's Department, complaint warrants were obtained for 44-year-old Christopher Shipman of Cumberland, Ky.
On the morning of Thursday, August 21, 2025, the Bell County Sheriff's Office, with the assistance of the US Marshals Service - Central Kentucky Fugitive Task Force, Harlan Police Department, Cumberland Police Department, Evarts Police Department, and the Harlan County Sheriff's Office, apprehended Shipman without incident and executed multiple search warrants in connection with the arrest warrants.
Shipman has been charged with (2) two counts of sodomy - 1st degree - victim under the age of 12, (2) two counts of sexual abuse - 1st degree - victim under the age of 12, and strangulation - 1st degree.
Christopher Shipman is lodged in the Harlan County Detention Center and is being held on a total of \$500,000 cash bonds.
Anyone who has also been a victim of this individual should call the Sheriff's Department. All calls will be kept confidential.
