AN ORDINANCE ADOPTING TEXT AMENDMENT 2024T-02 REMOVING ALL SECTIONS RELATED TO PLANNED UNIT DEVELOPMENT, RESIDENTIAL AND HIGHWAY BUSINESS, FROM THE ZONING REGULATIONS FOR BULLITT COUNTY AND THE CITIES OF HILLVIEW, LEBANON JUNCTION, MT. WASHINGTON, AND SHEPHERDSVILLE.

SUMMARY
SECTION ONE: Sets forth that the Zoning Regulations for Bullitt County and the Cities of Hillview, Lebanon Junction, Mt. Washington, and Shepherdsville for the City of Shepherdsville, Kentucky is hereby amended to remove all text regulations related to Planned Unit Development.
SECTION TWO: Sets forth that Section 5.900 Planned Unit Development, Residential and Highway Business is removed in its entirety.
SECTION THREE: Sets forth that Section 5.901 Site Plan and Development is removed in its entirety.
SECTION FOUR: Sets forth that Section 5.902 Permitted Uses and Variations is removed in its entirety.
SECTION FIVE: Sets forth that Section 5.903 Documentation Required for Planned Unit Development Application is removed in its entirety.
SECTION SIX: Sets for that Section 5.904 Permitted Uses and Variations is removed in its entirety.
SECTION SEVEN: Sets forth the severability clause.
SECTION EIGHT: Sets forth the repeal of prior ordinances in conflict with this ordinance.
SECTION NINE: Sets forth the publication requirement.
