## Couple indicted for sex abuse charges

SHEPHERDSVILLE - A Nelson County couple has been indicted for alleged actions

involving sexual abuse of a child. While another man has been indicted in the vehicular homicide of another per-

The indictments were recently handed down by the Bullitt County Grand Jury.

John Kevin Taylor, 48, and his wife, Michelle Taylor, 43, were indicted for incidents occurring between March 10 and

According to the indictments, John Taylor was charged with sexual abuse of a victim under 12 years of age, tampering with physical evidence and two counts of possession of material portraying a sexual performance by a minor. The charges against Michelle E. Taylor

were single counts of distribution of material portraying a minor in a sexual performance, complicity to tampering with physical evidence and failure to report child dependent neglect.

He was also charged with trying to destroy physical evidence. For Michelle Taylor, she was charged

with distributing matter which depicted a minor in a sexual performance. She also was charged with complicity to tamper with physical evidence.

And she faces a misdemeanor charge of failure to notify proper authorities that a child had been neglected or abused.

Michelle Taylor faces the most serious charge of a Class B felony, which is punishable by 10-20 years in prison. John Taylor faces a Class C felony, which is

## **New site** for wine, whiskey & ale event

SHEPHERDSVILLE - A little bit of rainwater won't stop local event coordinators from assisting veterans.

The Wine Whiskey & Ale Fest returns to Shepherdsville this year, presented by the City of Shepherdsville and the Shepherdsville/ Bullitt County Tourist and Convention Commission, with proceeds benefitting Active city) thought about this, and

year due to recent flooding, according to Odle. The new location is officially at 150 Frank E. Simon Ave., including the area between the Bullitt County Judicial Center Shepherdsville Community Center. Frank E. Simon Ave. will be closed for the duration of the event. Meanwhile, Odle mentioned that plenty

of parking would be available behind the Judicial Center and near the Bullitt County Courthouse. She said the south end of Frank E. Simon Ave., at Joe B. Hall Ave., would serve as an entrance/exit for parking access.

The Wine Whiskey & Ale Fest will feature tastings of local beverages as the event's showcase. Tasitings will be provided by Brooks Hill Winery, Forest Edge Winery, Four Roses Warehouse & Bottling, Gallant Fox Brewing Co., James B. Beam Distilling Co., Millanova Winery, Salt River Brewing Co., and Wight-Meyer Winery.

Odle said patrons can buy tasting wristbands for \$10, giving them access to all

participating booths.

Meanwhile, beverages will be available for individual purchases. Odle reminded that anyone purchasing an alcoholic beverage must show proof of age and receive a wristband. Tasting booths will be located at the front

portion of the event, near Frank E. Simon Ave., with several food trucks scheduled to provide a variety of tastes in the back of the lot. Odle said there will be a dining tent set up with public seating available. "You can bring a chair, but it might get a

little cramped in there," she said.




will also attend the event. She added that hand washing stations and porta-pottys would be located throughout the lot.
