SUMMARY

SECTION ONE:	Ordinance 025-013 is hereby amended.
SECTION TWO:	Section Two is amended to add the position, base pay rate, and authorized staffing level for the Administrative Department position of Payroll Clerk.
SECTION THREE:	Section Three is amended to authorize the Public Works Department to have a maximum of eight (8) full-time Public Works Maintenance I and Public Works Maintenance II employees, combined.
SECTION FOUR:	Section Six is amended to authorize 1 staffing level for the Police Department position of Lieutenant. Section Six is further amended to authorize the Police Department to have a maximum of forty-two (42) full-time officers and officer recruit positions combined.
SECTION FIVE:	Sets forth the severability clause.
SECTION SIX:	Sets forth the repeal of prior ordinances in conflict with this ordinanc
SECTION SEVEN:	Sets forth the publication requirement.
