to keep the offense on the field, but Lee was stopped for no gain to end the drive.

"I just went with my gut," the coach said of going on fourth down. "I thought we had a good chance to score. I thought we could get a touchdown and some momentum."

Still, the Cougars did take an early lead when they scored after getting the ball back following another punt. Lee had two runs for 34 yards. On third down from the 11yard line, Lee stepped left and then connected with Cameron Probus in the back of the end zone.

After forcing two punts to open the game, the Cougars had to defend a short field after a long kickoff return. Following two first downs, the Jaguar quarterback connected with Brady Cummins on a 24-yard touchdown.

East Jessamine lined up in the same formation after each touchdown with a holder and kicker, but tried different things, including the first touchdown.

quarter, following a Bullitt Central punt, the Jaguars marched 67-yards in six plays. The big play was the touchdown as Cummins hauled in a short pass in the flat, but then split two defenders for a 42-yard score.

Bullitt Central answered with a scoring drive. Lee had a 25-yard run to the 10-yard line, but on that play lineman Jordan Holbrook went down with a knee injury and did not return. It took four plays before the Cougars' scored when Lee connected with

Crenshaw on a 4-yard pass. That scored tied the game at 14-14 after Tripp O'Brien's extra point kick.

East Jessamine needed just half of the five minutes remaining in the first half to take the lead for good. The Jaguars converted a fourth down play and then two plays later scored on a 36-yard run.

Bullitt Central had 2:30 remaining on the clock and the Cougars again moved the ball. Lee connected on three passes for 20 yards and ran twice for 11 yards while Crenshaw covered nineyards putting the ball at the 21-yard line with 50 seconds remaining in the half. running for two points after However. teams called a time-out with 28 seconds. After his team's timeout, Faucett sent O'Brien on the field, but a bad snap/hold meant the attempt

never occurred. "We were in the game," Faucett said when asked about the team at halftime. "It was a seven-point game. We did not do much with the ball when we got it (to start the second half) and they scored and that put us in a hole."

Bullitt Central moved the ball over midfield when Lee ran for a first down on a fourth down play, but it was called back for an illegal block. That forced a punt that was returned to the Cougars' 36yard line. Three straight running plays covered the distance with the touchdown coming from the 7-yard line.

A point, or two points actually, that would haunt the Cougars the rest of the night came when Zac Naylor ran in the two-point conversion following the touchdown.

Midway through the third quarter, Bullitt Central got a 25-yard pass from Lee to Crenshaw and that started a drive that got as deep as the East Jessamine 19-yard line before a fourth-down pass came up well short of a first down.

The defense got the ball back when it held on a fourth down play and Bullitt Central went 60 yards in eight plays. Three of Lee's passes went to Crenshaw, including one for 31 yards. On a fourth down play from the 25-yard line, Lee hit Jose Barajas in stride over the middle and then senior went to the 3yard line. Crenshaw then powered in for the touchdown on the next play.

However, East Jessamine came around the right side and blocked the extra point, leaving the Cougars two scores down.

East Jessamine overcame two penalties on its next drive with one taking away a long touchdown. Still, the Jaguars later found the end zone as Cummins was open for a 16yard touchdown on the final play of the third quarter.

Down by three scores, the Cougars kept moving the ball. The drive to start the final frame took three minutes and 12 plays. Lee had runs of 12 and 21 yards. The touchdown came on a 20vard pass from Lee to Barajas.

The Cougars did not really need a two-point conversion, but they got it when a bad snap/hold led to O'Brien picking up the bouncing ball and running right. The leading scorer for the soccer

team got to the corner and then lowered his shoulder into a defender to get over the goal line for the points.

The defense made a stand after a failed on-sides kick, giving the Cougars the ball back at their own 42-yard line. Lee ran four times in the ensuing drive for 40-yards, the last one covering 10-yards, giving his team a first down at the 7-yard line. The next two passes were incomplete and then Lee was sacked for a one-vard loss.

Needing two scores, Faucett sent O'Brien onto the field, but his 25-yard field goal attempt was short.

With 3:49 remaining in the game, East Jessamine picked up a first down on a fourth knee on three straight snaps to run out the clock.

Bullitt Central does not have a lot of depth and there were times when they appeared tired, but they kept fighting and had a chance down the stretch to get a

"I was proud of our guys," Faucett said. "They battled."

Before the season began, the coach had talked about throwing the ball a majority of the time. However, in this game it was closer to 50-50 even if Lee and Crenshaw had the only carries. (O'Brien did have one carry, but it was not planned);

"We probably called passes 75 percent of the time," Faucett said. "But then A.J. either ran it or gave it to Kyler. They were doing things that under our RPO (run/pass option) reads we wanted to run it. The read said to hand it off."

NEXT GAME

Bullitt Central will make down play and then took a a long road trip on Friday as they will travel to northern Kentucky for a game against Scott High School. That team opened the season with an even higher scoring game than the Cougars as the Eagles fell at Campbell County 58-40.

Game time is set for 7:30 p.m. on Friday.
