

Fall break gives volleyball teams time to relax

SHEPHERDSVILLE – The high school volleyball season is in sort of a mid-season lull as the teams' catch their breath with the post-season just two weeks away.

With the exception of North Bullitt playing in a tournament this past weekend, the coaches have also lightened the schedule a bit as this week is Fall Break in Bullitt County.

North Bullitt did play two regular season matches early last week before competing over the weekend in the Fall Brawl event in Hardin County with games at both John Hardin and Elizabethtown high schools.

(Not all of the results from the tournament were posted at the newspaper's deadline so those results will be posted next week.)

The first part of the week was not a positive for the Lady Eagles as they went on the road and lost to both Oldham County and Bethlehem by 3-1 scores.

Against Oldham County, the Lady Eagles got 20 assists and 18 'digs' from senior Maci Milliner while Bracie Roeder also had 18 'digs'. At the net, coach Devyn Scott's

team got ten 'kill's from both Kara Gividen and Laila Brooks. Kass Bodytko had half of the team's 16 blocks.

The outcome was no better a day later in the loss to Bethlehem (25-13, 25-22, 20-25, 25-20).

Roeder had 20 'digs' in this match while Kenzie Gilmore had 13 assists. Milliner only played in three of the four sets but did have nine assists and 11 'digs.' The Lady Eagles got seven 'kills' each from Bodytko, Brooks and Shaelyn Woodson.

Despite it being Fall Break, North Bullitt will play three matches at home this week, including one on Thursday against Eastern.

Bullitt East only played one match last week as they also played Oldham County. This one was in Mount Washington with the Colonels pulling out a hard fought 3-2 (25-15, 22-25, 25-16, 21-25, 15-13) victory that was not decided until the final point.

With five sets of action, Bullitt East senior Brooke Morris was very busy as the Lady Charger setter had 43 assists. Morris also had ten 'digs.' Sophia Gorter had 15 'digs' while Camryn Kidwell had 11. Ten 'digs were credited to Julianna Edwards,

Aubrey Brown and Maddie Sturgeon. Edwards was also strong at the net, leading the team with 19 'kills'.

Bullitt East entered the week with a 16-9 record. The red and gold did start the week with three matches including two at home.

Bullitt Central took the court twice last week and came out on the short end each time. On Monday, there was a 3-0 (25-15, 25-7, 25-20) setback to LaRue County. The team did get a set win over Butler, but lost 3-1 (17-25, 25-19, 25-17, 25-22).

Against LaRue County, Ava Newton collected a dozen 'digs'. The Lady Cougars had four 'kills' each from Clara Wicker, Bailey Richards and Alayla Allen.

There were more points to go around in the match against Butler, one of the better teams in the Sixth Region. Newton had 14 'digs' in this match and Alija Hoxha had four service 'aces'. Addison Pedley had seven 'kills' while Allen had six. Awel Deng had six of the team's nine blocks.

Bullitt Central, starting the week with a 6-13 record, has just one match this week, a home tilt against Pleasure Ridge Park on Thursday.
