Spring is here! Get moving to manage stress, feel better, lose weight and live lon-

Exercise increases your overall health and your sense of well-being, which puts more pep in your step every day. But exercise also has some direct stress busting benefits.

It pumps u your endorphins. Physical activity helps bump up the production of your brain's feel good neurotransmitters, called endorphins. Although this function is often referred to as a runner's high, a rousing game of tennis or a nature hike also can contribute to this same feeling.

It's meditation in motion. After a bike ride or several laps in the pool, walked that mile you'll often find

that you've forgotten over your body and your day's irritations and concentrated only on your body's movements. As you begin to regularly shed your daily tensions through movement and physical activity, you may find that this focus on a single task and the resulting energy and optimism can help you remain calm and clear in everything you do.

It improves your mood. Regular exercise can increase self-confidence, it can relax you, and it can lower the symptoms associated with mild depression and anxiety. Exercise can also improve your sleep, which is often disrupted by stress, depression and anxiety. All of these exercise benefits can ease your stress levels and give you a sense of command

life, no matter what your age.

Consult with your doctor. If you haven't exercised for some time and you have health concerns, you may want to talk to your doctor before starting a new exercise routine.

Walk before you run. Build up your fitness level gradually. Excitement about a new program can lead to overdoing it and possibly even injury. For most health adults, the Department of Health and Human Services recommends getting at least 150 minutes oa week of aerobic activity such as brisk walking or swimming or 75 minutes a week of vigorous aerobic activity such as running. You can also
