Clay City Council Passes Ordinance, Sets 2025 Tax Rate

The Clay City Council met in regular session on Tuesday, September 9 with Mayor Jackie Edens presiding and five council members present. Council member Rocky Williams was not in attendance. City Clerk Christy Freeman was also present.

Following approval of the minutes from the August meeting, the bills and claims, and the city clerk's report, the council dealt with a short agenda in a session that lasted about 30 minutes.

Council members approved second reading of an ordinance which will allow street legal special purpose vehicles (side by sides) to be driven on streets within the city limits of Clay. The ordinance is similar to others passed by area communities and fiscal courts and coordinates with a law passed by the Kentucky General Assembly earlier this year.

The council held first reading of an ordinance setting the 2025 tax rate. Council members chose to adopt the compensating rate plus four per cent, and as a result, a public hearing will be held prior to the second reading of the ordinance. At press time, that public hearing had not been scheduled.

The tax rate adopted approved for real estate is 0.317 cents per \$100 of assessed valuation. The rate for tangible personal property is also 0.317 cents per \$100 of assessed valuation. That rate is expected to generate \$100,045. That is about \$4,000 more than tax revenue in 2024.

The tax for motor vehicles and water craft is 0.39 cents per \$100 of assessed valuation. The bank deposit tax is 0.025%. Both of those rates are set by state statutes.

All tax rates were approved on a 5-0 vote.

The monthly fire report, prepared by Fire Chief Jeremy Moore, showed members of the Clay Volunteer Fire Department made eight rescue runs and one fire run in August.

No further business came before the council, and the meeting was adjourned.
