## USDA Announces \$1.6 Million Investment In Morganfield Sewer Project

The Department of Agriculture Rural Development Kentucky State Director Trevor T. Burton and U.S. Congressman James Comer announced at a gathering at the City of Morganfield offices Monday that the USDA is investing over \$1.6 million in a sewer project in the Morganfield community. The funds will help offset the cost of Phase 3 of the city's sewer and water rehabilitation project.

"Water projects are not the most glamorous, but they are essential to the prosperity of our rural communities," Burton told a gathering of about 30 city employees and

residents. Burton add- lot of hard work from ed that "USDA Rural Development is proud to be a partner to water districts across the Commonwealth as they continue providing safe drinking water and sanitary waste disposal."

Burton also pointed out that since his appointment in May he has found that one consistent theme across the Commonwealth is the need for outdated sewer and water systems to be replaced. He added, that receiving this type of funding "doesn't just happen. It takes the hard work of the mayor, the judge/executive, the community and the Congressman to secure funds...and it takes a people in our office who have worked tirelessly to get this project underway."

The City of Morganfield will use a \$1.6 million loan to replace sewer lines, storm sewers and relocate a small section of water line. The present sewer system it estimated to have been installed in the early 1950s.

In his comments, Congressman Comer noted, "Infrastructure is the foundation of strong communities, and this investment in Morganfield's system marks a critical step forward for Union County. Projects like these are essential to

safeguarding public health, strengthening local economies and laying the ground work for long-term growth. I am grateful to USDA Rural for their continued commitment to investing in projects across Kentucky, and I look forward to the positive impact this investment will have on the Morganfield community."

Mayor Randy Greenwell thanked the agencies involved in securing the funding including USDA, GRADD, and the county. He told those gathered that the project has been a long time coming to fruition. He added that that the city has good agencies to work with and continue to build strong relationships with those groups. Judge/Executive Adam O'Nan also stressed the important role USDA has in helping rural Kentucky. In his comments he reminded those present that "this funding is not a burden on the (local) taxpayers; it's a \$1.6 million dollar bill that is not passed on to the city or county taxpayers."

Greenwell concluded Monday's program by introducing and thanking the city employees who work daily with the water and sewer systems, adding that the project "will be a huge asset to the City of Morganfield.

CITY OF STURGIS, KENTUCKY **ORDINANCE NO. 2025-09-17** 

AN ORDINANCE PROVIDING FOR THE IMPOSITION, LEVY, COLLECTION AND APPORTIONMENT OF REAL AND PERSONAL PROPERTY TAXES FOR THE CITY OF STURGIS, KENTCKY, UNION COUNTY, KENTUCKY FOR THE CALENDER YEAR OF JANUARY 1, 2025 THRU DECEMBER 31,2025 AND FISCAL YEAR JULY 1, 2025 THROUGH JUNE 30, 2026; FIXING THE DATE OF PAYMENT, AND PROVIDING A PENALTY FOR FAILURE TO TIMELY PAY.

WHEREAS, K.R.S 92.280 requires that the legislative body of each city levy an ad valorem tax for city purposes, and that this be done by ordinance to provide for sufficient revenue to operate city government

WHEREAS, K.R.S. Chapter 132 requires that this be calculated in accordance with the provisions of that chapter, and that such taxes shall become due and delinquent as set forth in K.R.S. 134.015 and that such taxes not paid when due shall be subject to penalties and interest

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF STURGIS, UNION COUNTY, KENTUCKY:

An ad valorem tax rate of \$0.524 per one hundred dollars (\$100.00) of assessed valuation of real property subject to taxation under the laws of the Commonwealth of Kentucky is hereby levied on all real property situated in the City of Sturgis, Kentucky, belonging to persons, partnerships, corporations and/or fiduciaries to be used for City purposes

SECTION 2. Other Personal (Tangible) Property.

An ad valorem tax rate of \$0.6567 per hundred dollars(\$100.00) of assessed valuation of personal property (other than motor vehicles and motorboats) subject to taxation under the laws of the Commonwealth of Kentucky is hereby levied on all personal property situated in the City of Sturgis, Kentucky, belonging to persons, partnerships, corporations and/or fiduciaries, and shall be used for City purposes.

**SECTION 3. Due Date, Payment, Discount and Penalty.**The taxes imposed in this Ordinance in Sections 1 and 2 shall be due and payable at the Union County Sheriff's Office in the Courthouse at 100 West Main Street, Morganfield, Kentucky 42437 in person or by mail postmarked on or before December 31, 2025. In accordance with K.R.S. 134.015, all 2025 taxes paid in person or postmarked on or before November 1, 2025 shall be discounted two percent (2%) for early payment. All or any portion of the tax which remains unpaid on December 31, 2025, but which is paid on or before January 31, 2026 shall be subject to a penalty of five percent (5%) of the taxes due and unpaid. All or any portion of the tax which is paid after January 31, 2026, shall be subject to a penalty of twenty-one percent (21%) of the taxes due and unpaid. Any and all unpaid taxes shall accrue interest at the statutory rate until paid in full. The penalty and interest as provided herein shall be added to said unpaid taxes and collected by the Sheriff or his or her designated deputy, until the end of collection in the Sheriff's Office on

April 15, 2026. SECTION 4. Lien on Property. In order to secure the payment of the real and personal ad valorem property taxes hereby levied and assessed, and all penalties, interest, fees, commissions, charges and other expenses, including court costs and attorney fees, incurred by reason of any delinquency in payment thereof or the process of collection, the City of Sturgis has a lien therefor upon the property upon which such taxes are-hereby levied and-assessed; anciany such lien has priority over all other obligations or liabilities for which the property is liable, except

state and county taxes, with which it as equal priority.

SECTION 5. Sheriff and Deputy Sheriff; County Attorney Authorization. The Sheriff or his authorized Deputy are hereby authorized to send out bills to all property owners within the City of Sturgis upon which a tax is levied and the Sheriff or his authorized Deputy is further authorized to provide property information to the County Attorney should the real or personal property tax imposed herein become delinquent, whereupon the County Attorney is authorized to file suit to collect all delinquent taxes plus court costs and expenses, including a reasonable attorney fee, incurred by reason of delinquency.

SECTION 6. Effective Date and Use Thereof. This Ordinance shall be effective immediately upon publication and applies to the 2025 calendar tax assessment and all receipts shall be used for city purposes and accounted in the 2025-2026 fiscal year and subsequent fiscal years in reference to delinguent collections. If any section, subsection, sentence, clause, or phrase of the Ordinance is held unconstitutional or otherwise invalid, such infirmity shall not affect the


