LEGAL NOTICE

CITY OF FOUNTAIN RUN, KENTUCKY SPONSORED BY: MAYOR MICHELE HOUCHENS ORDINANCE NO. 2025-003

AN ORDINANCE PROHIBITING THE USE OF ENGINE AND / OR COMPRESSION BRAKES WITHIN THE CITY OF FOUNTAIN RUN, KENTUCKY.

BE IT HEREBY ORDAINED by The City of Fountain Run, Monroe County, Kentucky,

SECTION ONE: WHEREAS, For the safety, welfare, and enjoyment of the Citizens of the City of Fountain Run, the Commission desires to regulate the use of Compression Braking Devices and Engine Braking Devices within the City Limits; and

SECTION TWO: WHEREAS, KRS 82.082 specifically authorizes municipalities to enact legislation that is in furtherance of a public purpose of the city and not in conflict with a constitutional provision or statute; and

SECTION THREE: WHERAEAS, state law does not regulate compression braking devices, and

SECTION FOUR: WHEREAS, certain portions of the City of Fountain Run lie in areas that are occupied by residences that are negatively affected by the practice of so-called "compression release engine braking" used by different types of vehicles, and

SECTION FIVE: WHEREAS, the noise disturbance emitted by certain vehicles when

using compression release engine braking constitute an unwarranted and unnecessary

intrusion into the safety, health, and welfare of the of the residents of the City of Fountain Run, Kentucky, and SECTION SIX: WHEREAS, the use of engine braking within certain portions of the corporate limits of Fountain Run may lead to additional motor vehicle collisions, since

when such compression engine braking is activated, no brake lights are activated by many vehicles utilizing compression braking devices, and SECTION SEVEN: WHEREAS, all legally-operated vehicles that are equipped with other means of providing a mechanism for the reduction of speed that allows said vehicles to reduce their speed in a manner that does not involve the loud, obtrusive, and

NOW, THEREFORE, BE IT ORDAINED BY THE FOUNTAIN RUN CITY COMMISSION, AS FOLLOWS:

unnecessary use of compression engine braking devices.

SECTION ONE: COMPRESSION RELEASE/BRAKING DEVICES ARE PROHIBITED FOR USE WITHIN THE CITY LIMITS OF FOUNTAIN RUN,

KENTUCKY: No person shall operate or cause to be operated at or upon any public highway within the Fountain Run City Limits any compression braking devices on any vehicle for any reason. For purposes of this section, a compression release device is defined as any mechanical exhaust device designed to aid in the braking or deceleration of any vehicle by converting engine power to compressed air which results in additional, excessive, loud, or explosive noise from such vehicle.

SECTION TWO: Penalty - any person found to be in violation of this ordinance shall be subject to a fine of not less than \$50, and not to exceed \$250 per violation.

SECTION THREE: SEVERABILITY: If any provision of this Ordinance is deemed by a court of competent jurisdiction to be unenforceable, the remaining provisions of this Ordinance shall continue to be in full force and effect.

SECTION FOUR: Any previous ordinance or resolution in conflict with this ordinance is hereby repealed.

SECTION FIVE: This ordinance shall become effective after passage, approval and publication as required Kentucky Revised Statues and other appropriate law.
