The selected bidder shall install the "588 Weathering Deck Girder Bridge - (FURNISHED BY OTHERS) at Mills Lane, CR1100A, off of Ky 1601, at Jones Creek, Latitude 36.84634 degrees, Longitude -83.219247 degrees. A set of plans signed and sealed by a Licensed Kentucky Engineer shall be furnished by others. A set of erection instructions shall be provided by others.

The prospective bidder shall clean up and expose existing abutments, adjust both abutment tops up in elevation, approximately 10 " (inches) to accommodate new structural steel beams (furnished by HCFC and fabricated by others in order to match existing roadway on both ends. This shall require drilling and anchoring rebar into

existing concrete structures. Existing abutment on KY 1601 side will have to be drilled and anchored to the roadside retaining wall as well, since the retaining wall footing is acting as the footer for the existing abutment wall, which is poured against the face of the roadway retaining wall. The 32' steel girder length appears to be longer than needed but it may be necessary because it would be hard to get an accurate measurement in the current condition and the possibility that the existing concrete structure may not be square which could create a situation where the new steel girders may need to be cut to fit. Bid price shall include all material, labor, and equipment for the substructure renovation. Contractor is to install only, structural steel beams, girder decking, diaphragms, and guardrail.

Bidder is responsible for traffic control along Ky 1601 during all phases of work. Traffic control shall meet all specifications as per KYTC - MUTC manual.

The tax rate levied last year as 41.5 cents per \$100 of assessed value and produced revenues in the amount of \$3,755,367. This year's compensating rate is 40.8 cents per \$100 of assessed value and will produce revenues in the amount of \$3,756,226. The Harlan County Fiscal Court proposes a tax rate of 41.5 cents per \$100 of assessed value which will produce a total of \$3,820,671 in revenues.

Revenue expected from New Property is \$0; revenue expected from Personal Property is \$844,076; revenue expected from Motor Vehicle is \$363,873; and revenue expected from Watercraft is \$5,481.

Revenue received in excess of last year's revenue will be used for general government expenses.
