With that in mind, WalletHub analyzed all 50 states using 52 key indicators of safety, grouped into five categories, to compile its 2025 list of the safest states in America, with Kentucky ranked 20th.

'Artificial intelligence (AI) is having a profound impact on all walks of life, and cybersecurity is no exception," said Ciampa, Professor of Analytics & Information Systems at Western Kentucky University. "Just as cybersecurity

professionals use both Generative AI (LLMs) and Analytical AI in their work, so too have threat actors turned to using AI. However, the adversarial usage of AI is not what is commonly perceived.

Ciampa said that one of "The safest states in the primary advantages of America protect their res- AI is that it "moves the starting line forward."

> "That is, it gives a 'head start' by accomplishing basic tasks (research, summarizing, etc.) so that humans can then move to a higher level of activity more quickly," he said, adding that this is precisely what threat actors have been doing to date.

"Research from Google Gemini and Anthropic Claude AI platforms has shown that threat actors are not using AI to create novel and previously unknown types of attacks, but rather they are using AI to accelerate their basic attacks."
