

The tax rate levied last year was 6.30 and produced revenues in the amount of \$1,994,626. This year's compensating rate is 5.70 and will produce revenues in the amount of \$2,037,610. The Woodford County Fiscal Court proposes to lower the current tax rate to 5.90 which will produce a total of \$2,109,105 in revenues.

Revenue expected from Personal Property is \$323,054; revenue expected from Motor Vehicle is \$309,719; and revenue from Watercraft is \$8,110. Revenue received in excess of last year's revenue will be used for county government operations
