Robertson County Fiscal Court renews contract with Bracken County EMS at June meeting

Members of the Robertson County Fiscal Court, including Judge-Exec. Valerie Miley and County Attorney Jesse Melcher, held their scheduled regularly monthly meeting on Friday, June 20, 2025, beginning at 10:00am, at the Robertson County Community Center.

Judge-Exec. called the meeting to order with a prayer, the Pledge of Allegiance, roll call with all magistrates present, acceptance of the agenda, and approval of the minutes from the three meetings held in May on the 9th,

Gile's report, accepted the Road Fund bills list and encumbrances, with add-on's. Judge-Exec. Miley said that the Road Department had taken that Friday off, because they had worked on Wed. night / Thurs. morning (June 18th and 19th) cleaning up downed trees from overnight storm,

and had also worked on the Juneteenth Holiday, Thursday, June 19th, with the food pantry during the food The court approved handout. The judge Road Foreman Shelby said that she will advertise for bids for paving at the ballpark, and that she will advertise for bids for paving the Justice Center parking lot, upon state approval.

The court approved Treasurer Sandy Fryman's report, accepted the General Fund bills list and encumbrances with add-ons, and approved the 2nd reading of Fiscal Year 2026 budget. The court was informed that the audit had been completed, and Judge-Exec. Miley thanked everyone for the good job, and that they had got a lot done. The court approved

Jailer Tim Wright's report, accepted the Jail Fund bills list and encumbrances, and approved the transfer of \$10,000.00 from the General Fund to the Jail Fund.

The court, along with Manage-Emergency ment Director Diane

Ellis, discussed painting Pinhook Tower, and before it could begin that it would have to be inspected by an inspector from Buffalo Trails, and that could be two months out. They also said the Federal Grant audit went well and approved a resolution to their contract Buffalo Trace, at an annual fee of \$541.60, which is the same amount as last year, which provides search and rescue, a drone team, and K-9 rescue. They also spoke about the Code Red phone text alerts, and approved Ms. Ellis to attend a conference in Louisville, Ky., which the county would be reimbursed for, sans the

The court discussed CD rates and approved the judge to sign documentation with People's Bank of Ohio, at a rate of 3.64% or higher.

Under new business, the court approved a yearly contract with Bracken County EMS Service, at a cost of \$2,500 each quarter, with a 60-day opt out

She also mentioned that the EMS runs for Bracken and Nicholas were based on location, and that Bracken County provides services to the northern portion of Robertson County, while Nicholas County provides services for the southern portion of the

county. The court approved the 1st reading of Senate Bill 63 - Street Legal UTV ordinance, which allows special purpose vehicles to travel on the roadways. The court discussed, in detail, another ordinance for golf carts on the roadways and the specific requirements the golf carts would require, but the court tabled that discussion for
