AN ORDINANCE AMENDING SECTION 6 OF ORDINANCE 2025-2, WHICH SECTION ADDRESSES APPEALS TO DETERMINATIONS OF ABANDONED URBAN PROPERTY Summary

AN ORDINANCE AMENDING SECTION 6 OF THE CITY OF MOUNT OLIVET VACANT PROPERTY COMMISSION AND ABANDONED URBAN PROPERTY TAX ORDINANCE 2025-2 SETTING FORTH APPEALS PROCEDURE AND NOW ESTABLISHING THE MUNICIPAL APPEALS BOARD OF THE CITY OF MOUNT OLIVET AS THE BOARD TO

HEAR APPEALS FROM A DETERMINATION OF REAL PROPERTY AS BEING ABANDONED URBAN PROPERTY. BE IT ORDAINED BY THE CITY OF MOUNT OLIVET, KENTUCKY, THAT SECTION 6 OF CITY OF MOUNT OLIVET

No later than February 1 of each year the Vacant Property Review Commission, with the assistance of the City Clerk, shall mail, by first class mail to owners of each abandoned urban property, as those names are listed in the City records, a notice that this property has been classified as abandoned urban property. The owner of any abandoned urban property who believes that his, her or its vacant property has been incorrectly classified may appeal such classification to the [Vacant Property Review Commission] Municipal Appeals Board of the City of Mount Olivet. Such appeal shall be in writing and shall be made no later than March 1 of that year and shall be made and heard as otherwise provided by the Municipal Appeals Board Ordinance of the City of Mount Olivet. The [Vacant Property Review Commission] Municipal Appeals Board of the City of Mount Olivet shall afford the owner the opportunity for a public hearing. If the [Commission] Municipal Appeals Board of the City of Mount Olivet finds that the property is incorrectly classified as abandoned urban property, it shall cause the property to be removed from the list of property so classified. [The Vacant Property Review Commission shall develop policies and procedures for conducting


in his death. Joshua E. Overstreet, 36, of East Union Road, Carlisle, Ky., was arrest-
