### CITY OF RUSSELL SPRINGS, KENTUCKY ORDINANCE 2025-02

#### AN ORDINANCE ADOPTING GREEN RIDGE DRIVE INTO THE CITY OF RUSSELL SPRINGS' CITY STREETS SYSTEM

WHEREAS, the City of Russell Springs recognizes the importance of maintaining and improving public infrastructure for the safety, convenience, and well-being of its residents and visitors; and

WHEREAS, the property known as Green Ridge Drive has been properly constructed and maintained in accordance with city standards, and it is determined to be in the public interest to officially adopt it into the City of Russell Springs' city streets system; and

WHEREAS, KRS Chapter 82 provides cities in Kentucky with the authority to adopt, maintain, and regulate public streets within their jurisdictions;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RUSSELL SPRINGS, KENTUCKY, AS FOLLOWS:

#### Section 1. Adoption of Green Ridge Drive Lane

The public right-of-way known as Green Ridge Drive, located within the City of Russell Springs, Kentucky, is hereby adopted and accepted into the City of Russell Springs' official city streets system for maintenance and regulation.

#### Section 2. Description of the Street

Green Ridge Drive is described as follows: DESCRIPTION OF A TRACT OF LAND, BY A RIGHT OF WAY SURVEY, THE PROPERTY OF CUMBERLAND LAND DEVELOPMENT, LLC. (DEED BOOK 238 PAGE 225, PLAT CABINET 3 SLIDE 1108), LOCATED ON THE SOUTHWEST SIDE OF BERNARD LANE APPROXIMATELY 600.00 FEET NORTHWEST OF U.S HIGHWAY #127, IN THE CITY OF RUSSELL SPRINGS, RUSSELL COUNTY, KENTUCKY AND MORE PARTICULARLY DESCRIBED AS FOLLOWS: Beginning at a found iron pin with cap #3831 on the southwest right of way of Bernard Lane (40.00 foot right of way) and a corner with Cumberland Land Development, LLC. (Deed Book 238 Page 225); thence, leaving Cumberland Land Development, LLC. and with the right of way, S 59°05'26" E 40.37 feet to a point and a corner with the aforesaid Cumberland Land Development, LLC.; thence, leaving the right of way and with Cumberland Land Development, LLC., S 38°39'56" W 227.11 feet to a point; thence S 38°31'38" W 610.32 feet to a found iron pin with cap #3831; thence N 51°00'25" W 40.00 feet to a found iron pin with cap #3831 and a corner with Green Ridge Senior Apartments, LLC. (Deed Book 291 Page 72); thence, leaving Cumberland Land Development, LLC. and with Green Ridge Senior Apartments, LLC., passing a corner with Karen and Ronald Hopper (Deed Book 338 Page 579) and the aforesaid Cumberland Land Development, LLC., N 38°31'38" E 610.09 feet to a found iron pin with cap #3831; thence, continuing with Cumberland Land Development, LLC., N 38°39'57" E 221.67 feet to the Point of Beginning, containing 0.766 Acres.

This survey is subject to all Covenants, Easements, Exceptions, Rights of Way and/or restrictions of record or not of record. The above description is for Right of Way acquisition. Grid North was observed in the field from the North side of the property, N 63°34'16" W 115.36 feet from the point of beginning, along a random baseline on February 7, 2025.

#### Section 3. Maintenance Responsibility

Upon the effective date of this ordinance, the City of Russell Springs shall assume full responsibility for the maintenance, repair, and any required improvements of Green Ridge Drive, consistent with city standards and procedures applicable to other public streets within the city.

#### Section 4. Inspection and Compliance

Prior to the adoption of this ordinance, Green Ridge Drive shall be inspected by the city's Streets Department or designated representative to confirm its compliance with applicable street construction and safety standards. Any deficiencies noted during the inspection must be resolved as a condition of adoption, unless otherwise approved by the city council.

#### Section 5. Repealer Clause

All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

#### Section 6. Severability

If any provision of this ordinance or its application to any person or circumstance is held to be invalid, the invalidity shall not affect other provisions or applications of the ordinance that can be given effect without the invalid provision or application, and to this end, the provisions of this ordinance are declared to be severable.

#### Section 7. Effective Date

This ordinance shall take effect after its passage and publication as required by law.
