REQUEST FOR STATEMENT OF QUALIFICATIONS

The City of Russell Springs is accepting Statements of Qualifications for engineering design, inspection and supervisor services to be performed in the Russell Springs Booster Pump Station Improvements Project. Firms wishing to be considered should send a sealed envelope containing **FOUR (4)** copies of a Statement of Qualifications labeled **"Russell Springs Booster Pump Station Improvements Project"** to LCADD, Attn: Michael Overby, P.O. Box 1570, Russell Springs, Kentucky 42642

Responses should be submitted by 4:00 p.m. Central Time on Friday, August 22, 2025.

Statements should include a description of the firm's capabilities and expertise in the field of engineering design and along with resumes of individuals to be assigned to the project, a listing of similar projects along with reference information, and a description of the firm's familiarity with the project area and the ability to provide responsive service to the City of Russell Springs. Firms responding to this request will be ranked according to the information submitted. The City will enter into negotiations with the highest ranked firm to execute an engineering services agreement subject to availability of funding. If the parties are unable to negotiate a satisfactory agreement, the second ranked firm will be contacted. Once a firm has been selected, all unsuccessful firms will be contacted.

Public funding is being sought for the project. The formal solicitation of consulting engineering firms is being conducted to fulfill the requirements of the funding agency.

Attention is particularly called to the requirements as to conditions of employment to be observed under the contract, Section 3, Segregated Facilities, Section 109, Title VI of the Civil Rights Act of 1964, E.O. 11246, the Anti-Kickback Act, Section 503/ADA, Section 402 Veterans of the Vietnam Era clause and Age Discrimination Act of 1975 clause requirements.
