The "Illinois Staats-Zeitung" was published in Chicago from 1848 to 1922. Until at least the mid 1890s it was printed in the complex but prestigious old German Fraktur alphabet instead of our familiar Roman letters. During the 20th century most German newspapers, magazines, and books gradually switched from printing in Fraktur to the simpler Roman alphabet.
