New law takes effect restricting drone use when hunting and fishing  
Regulation prohibits take of fish and wildlife with aircraft

New measures are now in place to help protect Kentucky's fish and wildlife resources from the increasing use of aircraft technologies by hunters and anglers in the field. Following adjournment of the Kentucky Interim Joint Committee on Natural Resources and Energy on Oct. 16, 2025, a

new administrative regulation (301 KAR 3:140) went into effect making it unlawful to use aircraft or unmanned aircraft in the take of fish or wildlife. "This regulation will provide guidance regarding the use of aircraft, including drones, while hunting, fishing or participating in other outdoor activities," said Maj. David Marques with the Kentucky Department of Fish and Wildlife Resources Law Enforcement Division. "It will also provide a framework for our wardens to work within when investigating and enforcing potential violations. This regulation has been needed for some

time, and we are happy to finally have it in place." Under the authority granted to Kentucky Fish and Wildlife by KRS 150.010(46), "take" includes pursue, shoot, hunt, wound, catch, kill, trap, snare or capture wildlife in any way and any lesser act designed to lure, attract or entice for these purposes; and to place, set, aim, or use any device, animal, substance or agency which may reasonably be expected to accomplish these acts; or to attempt to do these acts or to assist any other person in the doing of or the attempt to do these acts. Regulations Now in Effect:

A person shall not use an aircraft or unmanned aircraft system: To fish, hunt or take wildlife or to drive or herd any wildlife for the purpose of fishing, hunting or taking; or To harass any wildlife. Aircraft or unmanned aircraft systems may be used by: Kentucky Fish and Wildlife employees and contractors or agents acting on behalf of the agency when addressing human safety, law enforcement, research, management or other needs approved by the department; Authorized landowners or their agents to engage in lawful wildlife damage control activities; and Commercial fishers for use in locating or removing invasive carp. ORDINANCE 2025-05  
AMENDING HICKMAN COUNTY ORDINANCE 2008-3

AN ORDINANCE OF THE FISCAL COURT OF HICKMAN COUNTY, RELATING TO THE IMPOSITION AND PAYMENT INTO THE TREASURY OF HICKMAN COUNTY, KENTUCKY, OF LICENSE FEES BASED ON THE EXERCISE OF ACTIVITIES NECESSARY TO CARRY ON BUSINESSES, TRADES, PROFESSIONS AND OCCUPATIONS IN HICKMAN COUNTY, KENTUCKY. THIS LICENSE FEE IS FOR GENERAL CAPITAL OUTLAY PURPOSES, INCLUDING BUT NOT LIMITED TO ROADS, BRIDGES, EQUIPMENT PURCHASES, AND DEBT REDUCTION AT THE HICKMAN COUNTY DETENTION CENTER.

Pursuant to KRS 67.077 Passage of Ordinance and Amendments and Additions to the proposed Ordinance relating to the imposition and payment into the Treasury of Hickman County, Kentucky of License Fees based on the exercise of activities necessary to carry on businesses, trades, professions and occupations in Hickman County, Kentucky. This License Fee is for general capital outlay purposes, including but not limited to roads, bridges, equipment purchases, and debt reduction at the Hickman County Detention Center.

**MAXIMUM ANNUAL TAXATION**  
No taxpayer, whether individual or corporate, shall be required to pay more than One Thousand Dollars (\$1000.00) in any one calendar year; except that for calendar year 2026 no taxpayer shall be required to pay more than Seven Hundred Fifty Dollars (\$750.00). Ordinance was considered at the October 23, 2025 meeting of the Fiscal Court of Hickman County, Kentucky at 8:00 a.m. Central Standard Time in the Office of the Judge Executive of Hickman County, 116 S. Jefferson Street, Clinton, Kentucky. The second reading of this Amended Ordinance is scheduled for November 24, 2025 at 8:00 a.m.
