In accordance with KRS 350.070, notice is hereby given that Ferroglobe USA ARLR, LLC, 332 West Cumberland Gap Parkway, Suite 100, Corbin, Kentucky 40701, has applied for an amendment to an existing surface coal mining and reclamation operation located 2.0 miles east of Press in Breathitt County. The amendment will add 8.9 acres and delete 11.8 acres making a total of 539.82 acres within the amended permit boundary.

The operation is approximately 1.5 miles southeast from KY 1098's junction with KY 1111 and located immediately south of Quicksand Creek. The operation is located on the Guage and Noble U.S.G.S. 7 1/2 minute quadrangle maps.

The surface area to be disturbed is owned by Kentucky Union, Randolph Fugate Heirs:(Randy Lynn and Iva Fugate, Henry Clay and Julita Fugate, Phyllis and Wick Clemens, Thelma Johnson), Johnson Family Trust:(Carolyn Ulrich, Diana Louise Mehren, Deborah Johnson). The operation used contour and highwall mining.

The application has been filed for public inspection at the Department for Surface Mining Reclamation and Enforcement's London Regional Office, 1804 East Cumberland Avenue, Middlesboro, Kentucky 40965. **Fair Housing Resolution**
