Renovation of the Historic Breathitt County Jail
for the
Breathitt History Museum
College Avenue, Jackson, KY 41339

Scaled proposals clearly marked for BCAT / Breathitt History Museum will be received from qualified contractors by the Breathitt History Museum at the EXISTING History Museum 329 Broadway, 2nd Floor, Jackson KY (above the Senior Citizens Center) until **1:00 PM local time, Friday May 2, 2025**, for the Fit-up of the interior of the existing historic Breathitt County Jail into a space for the Breathitt County History Museum.

Bids received after this time shall not be accepted and will be returned unopened to the bidder. The project includes acceptance of all existing site conditions (which are to be inspected by all bidders prior to bidding) and work as specified in the Contract Documents dated March 15, 2025. Refer to Supplemental Instructions to Bidders and construction documents for additional information.

Work of the Project includes the last phase (Fit-Up) of a multi-phase renovation of the existing historic Breathitt Jail. Included in the scope of the work is interior work consists of addition of a restroom, new flooring, new painting, and the reinstallation of existing historic stair elements, new wood flooring and select doors and hardware. Alternates for the exterior items as well as exhibit, AV and furnishings are included.

A Mandatory Pre-Bid Meeting for all contractors will be held at the PROJECT SITE on **April 18, 2025, 1:00 PM**, local time. A walk-thru of the building and site for purpose of reviewing the conditions will occur at this time. In the event that a bidder cannot attend this date/time or has an emergency and communicates unavailability in advance, then accommodations will be made for either a rescheduled pre-bid meeting or a second pre-bid meeting to satisfy this requirement.

The Instructions to Bidders, Form of Proposal, Form of Contract, Plans and Specifications, and Forms of Bid Bond, Performance and Payment Bond and other contract documents may be examined through a free download from Lynn Imaging. Documents may be obtained from Lynn Imaging, 328 Old Vine St., Lexington, KY or at their website, www.lynnimaging.com. An electronic copy of a complete set of plans and specifications is available at no charge to contractors. Hard copy printed sets are available at cost to contractor. No partial sets will be issued. If documents are to be mailed, an additional non-refundable charge per set may be required. The successful bidder is responsible for all additional sets they may require.

Immediately following the scheduled closing time for receiving the bids, all proposals that have been completely filled out and have been properly submitted with the appropriate attachments in accordance with the Contract Documents will be publicly opened and read.

Bids must be accompanied by a certified check or bid bond, payable to the Owner in an amount of not less than 5% of the bid. The award of the contract shall be made on the basis of the lowest and best bid in the interest of the Breathitt History Museum. No bidder may withdraw his/her bid for a period of sixty (60) days after the date set for the bid opening. The Owner reserves the right to waive informalities and irregularities and shall have the right to reject any and all bids. The successful bidder shall provide a 100% Performance and Payment Bond.

This project is subject to both Davis Bacon Wage Rates, as well as the Build America, Buy America Act (BABAA) requirements under Title IX of the Infrastructure Investment and Jobs Act (IIJA), Pub. L. 177-58. Absent an approved waiver, all iron, steel, manufactured products, and construction materials used in this project must be produced in the United States, as further outlined by the Office of Management and Budgets regulation (reference 2 CFR 200) on the application of Buy America Preference in Federal Financial Assistance Programs for Infrastructure.
