Boyle County Cooperative Extension Service Facility Cleaning Services

The Boyle County Extension Service is seeking bids for contractual cleaning services to maintain the facility located at 99 Corporate Drive in Danville. The one-year contracted services would start April 1st, 2026, with renewal based on performance. Three buildings should be included in the bid: Main office building (27,000 sq ft) consisting of meeting rooms, storage space, public and private restrooms, and multiple kitchens; teaching barn (10,000 sq ft) consisting of office, meeting rooms, public restrooms, and storage space; and pavilion (1,000 sq ft) consisting of storage space and public restrooms. Service is 5 nights per week, Monday, Tuesday, Thursday, Friday, and Sunday. Tasks include general cleaning of all floors (sweeping, dust mopping, wet mopping, vacuuming) monthly shampooing of carpeted entrance rugs (6 rugs), cleaning entrance doors glass and doors; walls and baseboards; tables, chairs, and countertops, appliance surfaces; cleaning all restrooms and kitchens and sinks, water fountains throughout facilities, nightly changing of all trash, stocking of supplies for all dispensers. All cleaning supplies will be provided by the customer. Flexibility with scheduling work to accommodate large events or holidays is required by the contractor. Pricing for cleaning needs to be itemized per day of service.

Total pricing labor and materials provided by contractor to perform a light floor care (scrubbing/buffing tile floors) at the request of customer, includes staff area floors (typically once per year) of all vct tile flooring in both main building and barn building
Total pricing labor and materials provided by contractor to perform a thorough complete floor care treatment (stripping/waxing, sealing tile floors) for all buildings at request of customer, includes staff area floors of all vct tile flooring in both main building and barn building (typically every 3 years)
