Alum Springs Convenience Center has applied to the Kentucky Division for Air Quality for an initial permit to construct/operate a solid waste combustor and incinerator facility to be located at 775 Yates Road, Junction City, Kentucky 40440. The plant is classified as a Conditional Major source due to potential emissions of non-hazardous regulated air pollutants greater than a major source threshold. This permit contains federally enforceable limitations to restrict this source's potential emissions to less than a major source threshold.
