CITY OF PERRYVILLE, KENTUCKY ORDINANCE NO. 2026 – 002

AN ORDINANCE AMENDING ARTICLE 2 AND ARTICLE 4 OF THE DANVILLE-BOYLE COUNTY PLANNING AND ZONING COMMISSION JOINT ZONING ORDINANCE TO ENSURE COMPLIANCE WITH KRS 100.348 RELATED TO "QUALIFIED MANUFACTURED HOMES" WITHIN THE CITY OF PERRYVILLE.

In light of the Kentucky Legislature passing a bill related to Qualified Manufactured Homes, which is codified at KRS 100.348, it was necessary and appropriate for the City of Perryville to adopt amendments to Articles 2 and 4 of the Danville-Boyle County Planning and Zoning Commission Joint Zoning Ordinance, which were previously adopted by the Danville-Boyle County Planning and Zoning Commission, adopting and amending relevant definitions and land use restrictions. The full text of the ordinance is available for public inspection at Perryville City Hall during the City's regular business hours, located at 314 E Second Street, Perryville, Kentucky 40468.

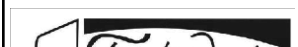
