NOTICE TO TAXPAYERS AND THIRD-PARTY PURCHASERS: 2025 DELINQUENT TAX BILLS

The amount set forth for each Certificate of Delinquency is the payoff through July 31, 2026. The sale of the Certificates of Delinquency will occur on August 26, 2026 at 10:00 a.m. The payoff for each bill will increase by one percent (1%) interest per month. The County Clerk will accept cash, money orders, cashier’s checks, or certified checks. Taxpayers can continue to pay their tax bill during normal business hours prior to the tax sale. Any payments received on Certificates of Delinquency that have been sold by the Boyle County Clerk’s Office after the sale will be returned to the remitter. A list of Certificates of Delinquency is updated weekly at boylecountyclerk.ky.gov or available at the County Clerk’s Office.

Therefore, the owner identified may no longer be the owner of the property for the bills that are delinquent.
