scheduled for 1:30 p.m. Tuesday, June 30, at the downtown square and Franklin Public Concert Hall and Park in Franklin.

BRASS serves survivors of domestic violence throughout south-central Kentucky with a 31-bed emergency shelter, satellite offices in three counties and programs focused on long-term independence and self-sufficiency. The organization

said its service region spans nearly 4,000 square miles, making it the second-largest Area Development District in Kentucky.

Officials said the mobile unit is intended to help close gaps in access for survivors living in rural communities far from established offices and services.

The grant funding was awarded during the Women's Fund Annual Dinner on Oct. 21, 2025,

through a competitive process in which finalist organizations present proposals and members vote on recipients.

Founded in 1980, BRASS provides emergency shelter, a 24-hour crisis line, legal advocacy, economic empowerment services and community education.

The organization serves nearly 3,000 survivors annually.
