CITY OF GLASGOW
ORDINANCE NO. 2025 - 3088

AN ORDINANCE AMENDING ORDINANCE NO. 2025-3071 ESTABLISHING AN ETHICAL CONDUCT CODE APPLICABLE TO THE OFFICERS AND EMPLOYEES OF THE CITY AND CITY AGENCIES.

SUMMARY OF ORDINANCE

THAT, WHEREAS, the General Assembly of the Commonwealth of Kentucky has enacted legislation requiring the City to enact and enforce a Code of Ethics governing the conduct of City Officers and Employees;

WHEREAS, the officials of this City are committed to the operation of a citygovernment manifesting the highest moral and ethical standards by its officers and employees and complying with all requirement of the Commonwealth's Local Government Ethics' Laws;

WHEREAS, on May 27, 2025, on second reading, the City adopted Ordinance 2025-3071 , establishing an ethical conduct code applicable to the officers and employees of the City and City agencies (sometimes referred to as "Ethics Code"); and

WHEREAS, since the adoption of Ordinance 2025-3071, it has been determined that certain amendments are needed to the Ethics Code;

NOW, THEREFORE, to keep the City's Ethics Code current and consistent with the recommendations of the Kentucky League of Cities, on January 12, 2026, the City adopted, on second reading, Ordinance No. 2025-3088, an Ordinance amending Ordinance 2025-3071 establishing an ethical conduct code applicable to the officers and employees of the City and City agencies, and which is summarized herein.

This Ordinance clarifies certain definitions.

This Ordinance clarifies that receiving a lawful campaign contribution is not a violation of the ethics code.

This Ordinance deletes certain provisions relating to outside employment, social media, disclosure of certain assets, and the admissibility of advisory opinions in court.

This Ordinance adds certain provisions regarding real estate interests of certain values.

This Ordinance eliminates certain provisions relating to certified mail requirements, staggered terms for the ethics board, ambiguities in ethics board qualifications, a hearing requirement before an ethics board member may be removed, filling vacancies on the ethics board, the 5-year review requirement for the Ethics Code, the 15-day requirement for issuing an ethics violation order, the confidentiality of advisory opinions, and that advisory opinions must first be reviewed by legal counsel, and the requirement that advisory opinions must be put on a website.

This Ordinance clarifies that city officials shall not disclose information discussed in closed session.

This Ordinance clarifies that the ethics board may reject a complaint not within its jurisdiction.

This Ordinance clarifies that ethics complaints lodged against the ethics board itself must go to the Mayor and City Council.

This Ordinance extends the notice of hearing time from 24 hours to 2 business days whenever an ethics complaint is lodged.

This Ordinance requires that all ethics board hearing decisions must be made in open session.

This Ordinance shall take effect upon its passage and publication according to law, but no earlier than January 15, 2026.
