

PUBLIC NOTICE 2025 GWC INDUSTRIAL USER SIGNIFICANT NON-COMPLIANCE

In accordance with the requirements of 40 CFR 403.8(f) (2) (viii) of the Federal Pretreatment Regulations and as required by the Kentucky Division of Water; the Glasgow Water Company must provide an annual publication listing all Industrial Users (IUs) which were in Significant Non-Compliance (SNC) during the reporting period of January 1, 2025 through December 31, 2025.

According to the Federal Pretreatment Regulations, an IU is in SNC for a Chronic Violation when 66% or more of all measurements taken during a 6-month period exceed the daily maximum or average limit for the same pollutant parameter. An IU is in SNC for a Technical Review Criteria (TRC) Violation when 33% or more of all measurements taken during a 6-month period exceed the product of the daily maximum limit or the average limit multiplied by the applicable TRC (TRC = 1.4 for BOD, TSS and Oil & Grease; TRC = 1.2 for all other pollutants except pH). An IU may also be in SNC for violations meeting other criteria in 40 CFR 403.8(f) (2) (viii).
